ORDER

Now comes the Virginia Board of Nursing ("Board") and Scott Kenneth Benson, R.N., as evidenced by the signature affixed below, enter into this Order affecting the license of Mr. Benson to practice as a professional nurse in the Commonwealth of Virginia.

FINDINGS OF FACT

After consideration of the evidence and statements concerning the allegations, the Board makes the following Findings of Fact:

1. Scott Kenneth Benson, R.N., was issued license No. 0001-222294 to practice as a professional nurse in the Commonwealth of Virginia on November 25, 2009. Said license expires on October 31, 2017.
2. By an Order entered January 4, 2013, Mr. Benson was subject to certain terms and conditions. One of the terms of this Order was Mr. Benson's compliance with all terms and conditions of his contract with the Health Practitioners' Intervention Program (currently known as the Health Practitioners' Monitoring Program, hereafter "HPMP"), pursuant to Chapter 25.1 of Title 54.1 of the Code of Virginia (1950), as amended, and 18 VAC 76-10-10, et seq., of the Regulations Governing the HPMP.
3. Mr. Benson has complied with all the terms and conditions of the above Order, and has successfully completed his contract with the HPMP.

CONCLUSIONS OF LAW

The Board concludes that Scott Kenneth Benson, R.N., has met the requirements of the Code of

Virginia (1950), as amended, and the Regulations of the Board of Nursing, and the Order entered January 4, 2013, and this matter is properly before the Board.


ORDER

WHEREFORE, on the basis of the foregoing Findings of Fact and Conclusions of Law it is hereby ORDERED that the terms and conditions placed on the license of Scott Kenneth Benson, R.N., to practice as a professional nurse in the Commonwealth of Virginia, be, and are hereby, TERMINATED.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.

Pursuant to Section 54.1-2400(10) of the Code, Mr. Benson may, not later than 5:00 p.m., on **March 20, 2017**, notify Jay P. Douglas, Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that he desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.


