### **CONSENT ORDER**

# JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Erin Leigh Evans, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Evans' application for licensure by examination to practice professional nursing in the Commonwealth of Virginia.

## FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Erin Leigh Evans submitted an application for licensure by examination to practice professional nursing in the Commonwealth of Virginia on November 15, 2016.
- 2. Ms. Evans violated Virginia Code § 54.1-3007(4) in that on April 2, 2012, she was convicted of two counts of credit card fraud and one count of obtaining credit card number by larceny, all felonies, in the Circuit Court of the City of Fredericksburg, Virginia.
  - 3. Ms. Evans otherwise meets the requirements of Virginia Code § 54.1-3017.

#### CONSENT

Erin Leigh Evans, by affixing her signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;

- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;
  - 4. I waive my right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for licensure to practice professional nursing in the Commonwealth of Virginia.

#### ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. Erin L. Evans is REPRIMANDED.
- 2. The application of Ms. Evans for licensure by examination to practice professional nursing in the Commonwealth of Virginia is APPROVED. Upon successful completion of the NCLEX-RN, Ms. Evans shall be issued an unrestricted license.
- 3. Ms. Evans shall comply with all laws and regulations governing the practice of professional nursing in the Commonwealth of Virginia.
