REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Jane Elliott, R.N., Ph.D., serving as

Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal conference on

November 7, 2016 in Henrico County, Virginia, to inquire into evidence that Stacy Elaine Paul, R.N.,

may have violated certain laws and regulations governing the practice of professional nursing in the

Commonwealth of Virginia.

Ms. Paul appeared at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated October 7, 2016, the Board sent a Notice of Informal Conference ("Notice") to

Ms. Paul notifying her that an informal conference would be held on November 7, 2016. The Notice

was sent by certified and first class mail to the legal address of record on file with the Board.

Recommended Findings of Fact and Conclusions of Law

1. Stacy Elaine Paul, R.N., was issued License Number 0001-233421 to practice

Registered Nurse on August 31, 2011, which is scheduled to expire on June 30, 2018. At all times

relevant to the findings herein, said license was in full force and effect. Her primary state of residence

is Virginia.

2. Ms. Paul violated Virginia Code § 54.1-3007(2) and (5) and 18 VAC 90-20-

300(A)(2)(e) of the Regulations Governing the Practice of Nursing in that during the course of her

employment with Preferred Pediatrics, Fredericksburg, Virginia, on six occasions from February 5,

2015 through March 3, 2015, Ms. Paul prepared fraudulent physician notes on company letterhead

indicating that her children had been seen by a physician for various injuries. The notes contained

medical diagnostic codes along with a written diagnosis and Ms. Paul submitted the notes to her

insurance company as accidental injury claims for monetary compensation.

3. Ms. Paul stated that she provided the diagnostic codes based on a manual that was kept

in the office and typed the doctor's name. Ms. Paul submitted six claims that could not be verified, for

a total of \$720.00. Ms. Paul indicated at the informal conference that the physician had seen the

children informally but had not entered notes into their record. At the informal conference, Ms. Paul

submitted documentation that she was reimbursing the \$720.00 and has an outstanding balance of

\$120.00.

4. Ms. Paul worked at Preferred Pediatrics off and on for 11 years. She is currently

employed at Falls Hill Gastroenterology Endoscopy Center.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate recommends that the Board issue an Order as follows:

1. Stacy Elaine Paul, R.N., is REPRIMANDED.

2. Stacy Elaine Paul, R.N., shall comply with all laws and regulations governing the

practice of professional nursing in the Commonwealth of Virginia.
