CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Taofeek Akolawole Quadri, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Mr. Quadri's application for licensure by examination to practice practical nursing in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Taofeek Akolawole Quadri submitted an application for license by examination to practice practical nursing in the Commonwealth of Virginia on August 26, 2016. He holds a current certificate to practice as a nurse aide in Virginia. His primary state of residence is Virginia.
- 2. By Order entered December 23, 2015, the Board reprimanded Mr. Quadri based on two criminal convictions and granted his application to practice as a certified nurse aide.
- 3. Mr. Quadri violated Virginia Code § 54.1-3007(4) in that he was convicted of the following misdemeanor crimes of moral turpitude in the General District Court of Fairfax County, Virginia:
- a. On March 19, 2014, he was convicted of petit larceny. He was sentenced to six months in jail with three months suspended and placed on probation for one year. He was ordered to pay fines and costs totaling \$82.00, which were paid in full on October 22, 2014.

- b. On April 13, 2015, he was convicted of petit larceny which involved the falsification of a time sheet pertaining to a Medicaid patient. He was sentenced to 180 days in jail, suspended, placed on probation for one year, barred from any Medicaid-related employment for one year, and ordered to pay \$9,737.30 in restitution to the Department of Medical Assistance Services. The restitution was paid in full effective July 30, 2015.
 - 4. Mr. Quadri otherwise meets the requirements of Virginia Code § 54.1-3020.

CONSENT

Taofeek Akolawole Quadri, by affixing his signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;
 - 4. I waive my right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for licensure to practice practical nursing in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. The application of Taofeek Akolawole Quadri for licensure to practice practical nursing in the Commonwealth of Virginia is APPROVED Upon successful completion of the NCLEX-PN examination, Mr. Quadri shall be issued an unrestricted license.
 - Taofeek Akolawole Quadri is REPRIMANDED.
- 3. Taofeek Akolawole Quadri shall comply with all laws and regulations governing the practice of practical nursing in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
