CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Committee of the Joint Boards of Nursing and Medicine ("Committee of the Joint Boards") and Paul Howard Werbin, L.N.P., as evidenced by their signatures hereto, in lieu of proceeding to a formal administrative proceeding, enter into the following Consent Order affecting Mr. Werbin's license to practice as a nurse practitioner in the category of certified registered nurse

anesthetist in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

Paul Howard Werbin, L.N.P., was issued License Number 0024-090514 to practice as a 1.

nurse practitioner in the category of certified registered nurse anesthetist on March 12, 1987, which

was summarily suspended by the Committee of the Joint Boards on January 27, 2017.

On October 13, 1989, the Committee of the Joint Boards entered an Order placing Mr. 2.

Werbin on probation for two years after making a finding that he had diverted Sufenta (C-II) and

fentanyl (C-II) for his personal and unauthorized use during the course of his employment with Sentara

Norfolk General Hospital and Leigh Memorial Hospital, Norfolk, Virginia, and self-administered these

medications while on duty. Further, the Committee of the Joint Boards made a finding that Mr. Werbin

had an opioid dependence.

Mr. Werbin violated Virginia Code § 54.1-3007(2), (5), (6), and (8) and 18 VAC 90-30-3.

220(4), (5) and (6) of the Regulations Governing the Licensure of Nurse Practitioners ("Regulations")

in that on October 28, 2016, while contracted to provide anesthesia services during a dental procedure at Goodove Oral Surgery, Chesapeake, Virginia, Mr. Werbin was found passed out in a facility bathroom with a wet bloody paper towel and a white tourniquet on the sink. Mr. Werbin, whose eyes were glassy and dilated when he was found, had two syringes in his pocket, and his personal bag contained a vial of fentanyl (C-II) that had been removed from The Hague Center for Cosmetic and Plastic Surgery, Norfolk, Virginia, without authorization or justification, a vial of propofol that had been removed from the Virginia Beach Eye Center without authorization or justification, a vial of midazolam (C-IV), and a vial of glycopyrrolate.

- 4. Mr. Werbin violated Virginia Code § 54.1-3007(2), (5) and (6) and 18 VAC 90-30-220(4), (5) and (6) of the Regulations in that on April 19, 2016, he diverted two vials of fentanyl from The Hague Center for Cosmetic and Plastic Surgery, and on an unknown date, he diverted a vial of propofol bearing the lot number IFEB2018/50172DJ from the Virginia Beach Eye Center, for his unauthorized use.
- Mr. Werbin has expressed his willingness to enter the Virginia Health Practitioners'
 Monitoring Program.

CONSENT

Paul Howard Werbin, L.N.P., by affixing his signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document and am represented by Jon Babineau, Esq.;
- 2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq. and Va. Code § 54.1-2408.1:

- 3. I acknowledge that I have the following rights, among others: the right to a formal administrative hearing before the Committee of the Joint Boards; the right to representation by counsel; and the right to cross-examine witnesses against me;
 - I waive my right to a formal hearing;
- 5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Committee of the Joint Boards is a party;
- 6. I consent to the entry of the following Order affecting my licensure to practice as a nurse practitioner in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Committee of the Joint Boards of Nursing and Medicine hereby ORDERS as follows:

- 1. The license issued to Paul Howard Werbin, L.N.P., to practice as a nurse practitioner in the Commonwealth of Virginia is INDEFINITELY SUSPENDED.
 - The license of Paul Howard Werbin, L.N.P., will be recorded as SUSPENDED.
- 3. Should Paul Howard Werbin, L.N.P., seek reinstatement of his license, an administrative proceeding shall be convened to consider such application. At such time, the burden shall be on Mr. Werbin to demonstrate that he is safe and competent to return to the practice of a nurse practitioner. Mr. Werbin shall be responsible for any fees that may be required for the reinstatement and/or renewal of the license prior to issuance of the license to resume practice.
- 4. The suspension shall be STAYED upon proof of Mr. Werbin's entry into the Virginia Health Practitioners' Monitoring Program ("HPMP").

Upon a stay of the suspension, Mr. Werbin shall comply with all terms and conditions 5. of the Virginia HPMP for the period specified by the Virginia HPMP.

Upon receipt of evidence of Mr. Werbin's participation in and successful completion of 6.

the terms specified by the Virginia HPMP, the Virginia Committee of the Joint Boards, at its

discretion, may waive Mr. Werbin's appearance before the Committee of the Joint Boards and conduct

an administrative review of this matter, at which time he may be issued an unrestricted license to

practice as a nurse practitioner.

Mr. Werbin shall comply with all laws and regulations governing the licensure of nurse 7.

practitioners in the Commonwealth of Virginia.

Failure to comply with the terms and conditions of the stay of suspension shall result in 8.

the immediate rescission of the stay of suspension of the license of Mr. Werbin and the license shall be

recorded as suspended. After any rescission of the stay of suspension, Mr. Werbin may, within thirty-

three (33) days of the effective date of the rescission, request a formal administrative hearing before

the Committee of the Joint Boards.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall

remain in the custody of the Department of Health Professions as a public record, and shall be made

available for public inspection and copying upon request.
