### LEGAL AUTHORITY AND JURISDICTION:

- 1. This formal hearing is being held pursuant to Virginia Code §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11). This proceeding will be convened as a public meeting pursuant to Virginia Code § 2.2-3700.
- 2. At the conclusion of the proceeding, the Board and Committee of the Joint Boards are authorized to take any of the following actions:
  - Exonerate you;
  - Reprimand you;
  - Require you to pay a monetary penalty;

If you fail to appear at the formal hearing, the Board and Committee of the Joint Boards may proceed to hear this matter in your absence and may take any of the actions outlined above.

You have the right to the information on which the Board and Committee of the Joint Boards will rely in making its decision, to be represented by counsel at this proceeding, to subpoena witnesses and/or documents, and to present relevant evidence on your behalf.

Exhibits may not be sent by facsimile or e-mail.

The Commonwealth must file any objections to your submissions in writing, addressed to Darlene Graham at the Board office, no later than **February 15, 2017**. If no objections have been received by **February 15, 2017**, the evidence will be distributed to the Board members for their review, and will be considered by the Board and Committee of the Joint Boards as evidence when it deliberates upon your case. If the Commonwealth raises objections, you have until **February 20, 2017**, to file your response to the objections, in writing and addressed to Darlene Graham at the Board office. The Chair of the proceeding will rule on the motion.

- 2. Deadline for filing motions, including requests for continuance or objections to exhibits, in writing, to Darlene Graham at the above address: **February 10, 2017**. NOTE: Failure to object to the distribution prior to the proceeding will not affect your right to contest any information contained in these documents at the proceeding.

The Chair of the proceeding will rule on the motion.

#### OTHER PRE-HEARING MOTIONS

If you or Adjudication Specialist David Kazzie desire to make any pre-hearing motions regarding matters other than the exhibits, including offers of settlement, each of you is directed to file motions, in writing, addressed to Darlene Graham at the Board office by February 10, 2017. Responses to motions filed must be submitted by February 10, 2017. The Chair of the proceeding will rule on the motion.

## REQUEST FOR A CONTINUANCE

Absent exigent circumstances, such as personal or family illness, a request for a continuance after **February 10, 2017**, will not be considered. If you obtain counsel, you should do so as soon as possible, as a motion for a continuance due to the unavailability of counsel will not be considered unless received by **February 10, 2017**.

### STATEMENT OF ALLEGATIONS

The Board alleges that:

- 1. At all times relevant hereto, Paul Howard Werbin, R.N., L.N.P., L.N.P., was licensed to practice professional nursing and to practice as a nurse practitioner in the category of a certified registered nurse anesthetist in the Commonwealth of Virginia.
- 2. Mr. Werbin violated Virginia Code § 54.1-3007(2), (5), (6), and (8) and 18 VAC 90-20-300(A)(2)(c) of the Regulations Governing the Practice of Nursing ("R.N. Regulations") and 18 VAC 90-30-220(5) of the Regulations Governing the Licensure of Nurse Practitioners ("L.N.P. Regulations") in that on or about October 28, 2016, while contracted to provide anesthesia services during a dental procedure, at Goodove Oral Surgery, Chesapeake, Virginia, Mr. Werbin was found passed out in a facility bathroom with a wet bloody paper towel and a white tourniquet on the sink. Mr. Werbin, whose eyes were glassy and dilated when he was found, had two syringes in his pocket, and his personal bag contained a vial of fentanyl (C-II) that had been removed from the Hague Center for Cosmetic and Plastic Surgery, Norfolk, Virginia, without authorization or justification, a vial of propofol that had been removed from the Virginia Beach Eye Center without authorization or justification, a vial of midazolam (C-IV), and a vial of glycopyrrolate.
- 3. Mr. Werbin violated Virginia Code § 54.1-3007(2), (5) and (6), 18 VAC 90-20-300(A)(2)(c) of the R.N. Regulations and 18 VAC 90-30-220(5) and (6) of the L.N.P. Regulations in that on or about April 19, 2016, he diverted two vials of fentanyl from the Hague Center for Cosmetic and Plastic Surgery, and on an unknown date, he diverted a vial of propofol bearing the lot number 1FEB2018/50172DJ from the Virginia Beach Eye Center, for his personal and unauthorized use.
