CONSENT ORDER

The Virginia Board of Nursing ("Board") and Austin N. Lovell, as evidenced by her signature hereto, enter into the following Consent Order affecting Mr. Lovell's application for licensure by examination to practice as a professional nurse in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- By application received May 20, 2015, Austin N. Lovell applied for licensure by examination 1. to practice as a professional nurse in the Commonwealth of Virginia. His primary state of residence is Virginia.
- 2. On November 29, 2012, Mr. Lovell was convicted in the District Court of New Hanover County, North Carolina of one count of misdemeanor larceny and four counts of obtaining property by false pretenses, all crimes involving moral turpitude. He was sentenced to 180 days incarceration, with all 180 days suspended, ordered to enroll in drug treatment and pay fines, costs, and restitution. He was also placed on probation for two years.
- Mr. Lovell provided evidence to the Board that all court costs and restitution were paid in full 3. on November 29, 2014.

CONCLUSIONS OF LAW

- 1. Finding of Fact No. 3 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
 - Mr. Lovell otherwise meets the requirements of § 54.1-3017 of the Code. 2.

CONSENT

Austin N. Lovell, by affixing his signature hereon, agrees to the following:

- 1. He has been advised to seek advice of counsel prior to signing this document;
- 2. He acknowledges that without his consent, no legal action can be taken against him except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. He acknowledges that he has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against him;
 - He waives all such right to an informal conference;
- 5. He admits to the Findings of Fact and Conclusions of Law contained herein waives his right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. He consents to the entry of the following Order affecting his application for licensure to practice professional nursing in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of Austin N. Lovell for licensure by examination as a professional nurse is APPROVED. Upon successful completion of the NCLEX-RN examination, Mr. Lovell shall be issued an unrestricted license to practice as a professional nurse in the Commonwealth.
 - Mr. Lovell is hereby REPRIMANDED.
- 3. Mr. Lovell shall maintain a course of conduct in his capacity as a professional nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
