The Board of Nursing (“Board”) has received verification that you have been dismissed from the Virginia Health Practitioners’ Monitoring Program.


In accordance with the Order of the Board entered January 24, 2017, the stay of indefinite suspension has been summarily rescinded and your license to practice Registered Nurse in the Commonwealth of Virginia is **INDEFINITELY SUSPENDED** effective this date.

If you wish to contest this action, you may request a formal hearing before the Board. A request for a formal hearing on this matter must be in writing, addressed to the attention of Jay Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, and received by the Board within 33 days from the date of this letter. Upon receipt of your timely written request, a formal hearing will be scheduled. Please note that failing to request a formal hearing within 33 days will not prevent you from applying for reinstatement of your license at a later date.

Pursuant to Virginia Code § 54.-2400.2, this letter shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection and copying upon request.
