CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Robin Jeanette Harris, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Harris's application for certification by endorsement to practice as a nurse aide in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Robin Jeanette Harris submitted an application for certification by endorsement to practice as a nurse aide in the Commonwealth of Virginia on October 29, 2016. Ms. Harris also holds a certificate to practice as a nurse aide in the state of Alabama.
- 2. Ms. Harris violated Virginia Code § 54.1-3007(4) in that between 1982 and 1985, Ms. Harris was convicted of three felonies, including grand larceny, welfare fraud and possession of burglary tools, three misdemeanor counts of petit larceny, one misdemeanor count of giving false information, and one misdemeanor count of obtaining money by false pretenses, all of which were misdemeanors involving moral turpitude.
 - 4. Ms. Harris otherwise meets the requirements of Virginia Code § 54.1-3023.

CONSENT

Robin Jeanette Harris, C.N.A., by affixing her signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;

- 2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;
 - 4. I waive my right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for certification to practice as a nurse aide in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. Robin Jeanette Harris is REPRIMANDED.
- 2. Ms. Harris' application for certification by endorsement to practice as a nurse aide in the Commonwealth is APPROVED.
- Robin Jeanette Harris shall comply with all laws and regulations governing the practice of nurse aides in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
