Dear Ms. McLean:

Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that your license to practice nursing in the Commonwealth of Virginia has been mandatorily suspended by the enclosed Order entered January 30, 2013. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license or certificate to do so suspended shall be guilty of a felony. Please return your license to Jay P. Douglas, Executive Director of the Virginia Board of Nursing, at the above address, immediately upon receipt of this letter.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your license, and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of sixty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your license shall require the affirmative vote of three-fourths of the members present of the Board of Nursing.

In accordance with Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), I, Dianne L. Reynolds-Cane, M.D., Director of the Virginia Department of Health Professions, received and acted upon evidence that Tomeka Marshelle Redd McLean, L.P.N., pled guilty and was found to be guilty of felony charges in the Circuit Court for the County of Chesterfield, Virginia, to wit:

1. Three (3) Counts of Utter Forged Document;
2. One (1) Count of Obtain Money/Property by False Pretense.


A certified copy of the Trial Order is attached to this Order and is marked as Commonwealth's Exhibit No. 1.

WHEREFORE, by the authority vested in the Director of the Department of Health Professions pursuant to Section 54.1-2409 of the Code, it is hereby ORDERED that the license of Tomeka Marshelle Redd McLean, L.P.N., to practice nursing in the Commonwealth of Virginia be, and hereby is, suspended.

Upon entry of this Order, the license of Tomeka Marshalle Redd McLean, L.P.N., will be recorded as suspended and no longer current. Should Ms. McLean seek reinstatement of her license pursuant to Section 54.1-2409 of the Code, she shall be responsible for any fees that may be required for the reinstatement and renewal of her license prior to issuance of her license to resume practice.

Pursuant to Sections 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be

made available for public inspection and copying upon request.

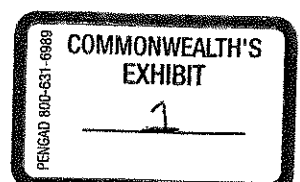
The defendant came before the Court for trial and appeared in person with counsel, David S. Clements. The Commonwealth was represented by Kenneth E. Nickels.

The defendant was arraigned and pled **GUILTY** to obtaining money or property by false pretenses and 3 counts of uttering a forged document.

The Court, being of the opinion that the defendant fully understood the nature and effect of the plea(s) and of the penalties that may be imposed upon conviction(s) and of the waiver of trial by jury and of appeal, proceeded to hear the evidence without a jury.

The Court, having heard the evidence and argument of counsel, finds the defendant **GUILTY** of the offense(s) indicated below, but refers the defendant to the Probation and Parole Officer of this district for the preparation of a pre-sentence report, and to the Virginia Department of Corrections for an evaluation for participation in the Detention/Diversion Center programs, returnable on April 11, 2013 at 1:00 p.m.


