FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. James Clifford Woods, Jr., C.N.A. was issued Certificate Number 1401-177534 to

practice as a nurse aide on December 16, 2015, which is scheduled to expire on December 31, 2017.

2. Mr. Woods violated Virginia Code §§ 54.1-3007(3) and 54.1-3027(2) in that from

December 20, 2014 through November 23, 2015, during his employment with Abingdon Health and

Rehabilitation, Abingdon, Virginia, Mr. Woods practiced as a certified nurse aide without a valid

certificate issued by the Virginia Board of Nursing.

3. On November 25, 2015, Mr. Woods's employment with Abingdon Health and

Rehabilitation was terminated.
