CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Courtney Daneeka Harvey, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Harvey's application for licensure by examination to practice practical nursing in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Courtney Daneeka Harvey submitted an application for licensure by examination to practice practical nursing in the Commonwealth of Virginia on November 11, 2016. Ms. Harvey holds Certificate No. 1401-142243 to practice as a nurse aide in the Commonwealth of Virginia. Said certificate is scheduled to expire on January 31, 2018.

3. Ms. Harvey violated Virginia Code § 54.1-3007(4) in that on October 4, 2012, in the General District Court of Virginia Beach, Virginia, Ms. Harvey was convicted of two counts of petit larceny, a misdemeanor involving moral turpitude.

4. Ms. Harvey otherwise meets the requirements of Virginia Code § 54.1-3020 and 18 VAC 90-20-190 of the Regulations Governing the Practice of Nursing.

CONSENT

Courtney Daneeka Harvey, L.P.N., by affixing her signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;

2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 *et seq.*;

3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;

4. I waive my right to an informal conference;

5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;

6. I consent to the entry of the following Order affecting my application for licensure to practice practical nursing in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

1. Courtney Daneeka Harvey is REPRIMANDED.

2. The application of Courtney Daneeka Harvey for licensure to practice practical nursing in the Commonwealth of Virginia is APPROVED. Upon successful completion of the NCLEX-LPN examination, Ms. Harvey shall be issued an unrestricted license.

3. Ms. Harvey shall comply with all laws and regulations governing the practice of practical nursing in the Commonwealth of Virginia.

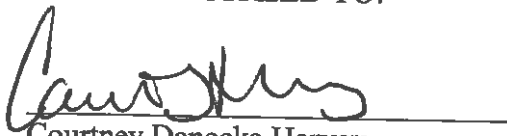

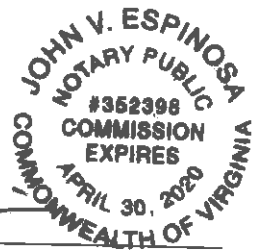
