FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Tracy Haynes Branch, L.P.N. was issued License Number 0002-045070 to practice practical nursing on November 25, 1991, which is scheduled to expire on July 31, 2017. Her primary state of residence is Virginia.
- 2. Ms. Branch violated Virginia Code § 54.1-3007(2) and (5) and 18 VAC 90-20-300(A)(2)(e) of the Regulations Governing the Practice of Nursing in that on February 21, 2016, and February 28, 2016, during the course of her employment with American Critical Care Services, Inc., she submitted falsified time sheets for hours that she did not work.
- 3. On February 29, 2016, Ms. Branch's employment with American Critical Care Services, Inc. was terminated.
