CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Felicia Eloise Hall, L.P.N., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Hall's license to practice practical nursing in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Felicia Eloise Hall, L.P.N., was issued License Number 0002-091453 to practice practical nursing on September 17, 2014, which is scheduled to expire on February 28, 2018. Her primary state of residence is Virginia.
2. By Consent Order entered on December 16, 2016, the Board found that Ms. Hall was unsafe to practice practical nursing due to substance abuse. The Board took no action contingent upon Ms. Hall's continued participation in the Health Practitioners' Monitoring Program ("HPMP"), as described by Term Number 1 of the Consent Order.
3. Ms. Hall violated Term Number 1 of the Board's Order in that on March 17, 2017, the Monitoring Program Committee adopted the recommendations of HPMP and dismissed Ms. Hall from the program due to her non-compliance with treatment and toxicology screening, as evidenced by the following:
 - a. On February 20, 2017, Ms. Hall provided a dilute urine sample for toxicology screening.
 - b. On February 24, 2017, Ms. Hall withdrew from the intensive outpatient program.

- c. On February 27, 2017, Ms. Hall missed a toxicology screening.
 - d. On March 6, 2017, Ms. Hall gave verbal notice to HPMP of her decision to withdraw from the program.
4. Pursuant to Virginia Code § 54.1-2400.2(K), the Board considered whether to disclose or not disclose Ms. Hall's health records or health services.

CONSENT

Felicia Eloise Hall, L.P.N., by affixing her signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;
2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 *et seq.*;
3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;
4. I waive my right to an informal conference;
5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
6. I consent to the entry of the following Order affecting my licensure to practice practical nursing in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

1. Felicia Eloise Hall, L.P.N., is REPRIMANDED.
2. The Board accepts the VOLUNTARY SURRENDER for INDEFINITE SUSPENSION of Felicia Eloise Hall's license to practice practical nursing in the Commonwealth of Virginia.
3. The license of Ms. Hall will be recorded as SUSPENDED.
4. This suspension applies to any multistate privilege to practice practical nursing.
5. Should Ms. Hall seek reinstatement of her license, an administrative proceeding shall be convened to consider such application. At such time, the burden shall be on Ms. Hall to demonstrate that she is safe and competent to return to the practice of practical nursing. Ms. Hall shall be responsible for any fees that may be required for the reinstatement and/or renewal of the license prior to issuance of the license to resume practice.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
