FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Christy Ann Wright Jordan, C.N.A., was issued Certificate Number 1401-106577 to

practice as a nurse aide on October 23, 2004, which expired on October 31, 2015. Ms. Jordan

submitted an application for reinstatement of her certificate to practice as a nurse aide in the

Commonwealth of Virginia on July 27, 2016.

2. Ms. Jordan violated Virginia Code § 54.1-3007(4) in that on December 10, 2015, she

was convicted of petit larceny in the Circuit Court for the City of Salem, Virginia.

3. Ms. Jordan provided evidence that she has paid all associated court costs related to her

conviction.

4. Ms. Jordan otherwise meets the requirements for reinstatement of her certificate to

practice as a nurse aide.

- 2. The application of Ms. Jordan for reinstatement of her certificate to practice as a nurse aide is APPROVED without restriction.
- 3. Ms. Jordan shall comply with all laws and regulations governing the practice of certified nurse aides in the Commonwealth of Virginia.
