REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Nancy K. Durrett, R.N., M.S.,

serving as Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal

conference on October 4, 2016 in Henrico County, Virginia, to inquire into evidence that Bedelia

McCoy Hall, C.N.A., may have violated certain laws and regulations governing the practice of

certified nurse aides in the Commonwealth of Virginia.

Ms. Hall did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated August 30, 2016, the Board sent a Notice of Informal Conference ("Notice") to

Ms. Hall notifying her that an informal conference would be held on October 4, 2016. The Notice was

sent by certified and first class mail to the legal address of record on file with the Board. According to

the United States Postal Service website, the Notice sent by certified mail was forwarded to an address

in North Carolina where it remains available for pickup. The Notice sent by first class mail was not

returned to the Board office. Accordingly, the Agency Subordinate concluded that adequate notice

was provided to Ms. Hall and the informal conference proceeded in her absence.

Recommended Findings of Fact and Conclusions of Law

- 1. Bedelia McCoy Hall, C.N.A., was issued Certificate Number 1401-101360 to practice as a nurse aide on December 24, 2003, which is scheduled to expire on December 31, 2016. At all times relevant to the findings herein, said certificate was in full force and effect.
- 2. Bedelia McCoy Hall, C.N.A., violated Virginia Code § 54.1-3007(2), (5) and (8) and 18 VAC 90-20-100(2)(h) of the Regulations Governing Certified Nurse Aides in that during the course of her employment with Harbourway Assisted Living at Atlantic Shores, Virginia Beach, Virginia ("Atlantic Shores"), between June, 2015 and September, 2015, she made charges to Resident A's credit card in the amount of approximately \$1,898.41 without Resident A's authorization or consent.
- 3. Finding of Fact and Conclusion of Law No. 2 constitutes a Finding of Misappropriation of patient property pursuant to 42 CFR §483.156(b)(2) and (c)(1)(iv)(D) of the Code of Federal Regulations.
- 4. On February 5, 2016, Ms. Hall's employment with Atlantic Shores was involuntarily terminated for unacceptable job performance due to theft.
- 5. On April 18, 2016, someone claiming to be Ms. Hall's daughter reported to an investigator with the Department of Health Professions ("DHP") that Ms. Hall had committed suicide. The individual failed to produce a copy of Ms. Hall's death certificate or obituary despite repeated requests from the DHP. No verifiable documentation of Ms. Hall's death was located.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate recommends that the Board issue an Order as follows:

1. The certificate of Bedelia McCoy Hall, C.N.A., to practice as a nurse aide in the Commonwealth of Virginia is REVOKED.

- 2. The certificate of Bedelia McCoy Hall, C.N.A., will be recorded as REVOKED.
- 3. A Finding of Misappropriation of patient property shall be ENTERED against Bedelia McCoy Hall, C.N.A., in the Virginia Nurse Aide Registry pursuant to 42 CFR § 483.13(c)(1)(ii)(B) and 42 CFR § 483.156(b)(2) and (c)(1)(iv)(D). This finding prohibits Bedelia McCoy Hall's employment as a certified nurse aide in any long-term care facility that receives Medicare or Medicaid reimbursement, according to 42 CFR § 483.13(c)(1)(ii)(B).
