FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Wendy Lynn Hunt, C.M.T. was issued Certificate Number 0019-007314 to practice massage therapy on March 20, 2008, which expired on February 28, 2016, was renewed on June 16, 2016, and is scheduled to expire on February 28, 2018.
- 2. Ms. Hunt violated Virginia Code §§ 54.1-3007(3) and (5) and 54.1-3008(A)(7) in that during the course of her employment with the Ritz Carlton Hotel/Spa, McLean, Virginia, between February 29 and June 16, 2016, she practiced massage therapy and held herself out as a certified massage therapist after her certificate had expired.

This penalty shall be paid to the Board by certified check or money order made payable to the Treasurer of Virginia within 90 days from the date of entry of this Order. Failure to pay the full monetary penalty by the due date may cause the matter to be sent for collection and constitutes grounds for an administrative proceeding and further discipline.
- 2. Wendy Lynn Hunt, C.M.T., shall comply with all laws and regulations governing the practice of massage therapy in the Commonwealth of Virginia.

3. Any violation of the foregoing terms and conditions of this Order or any statute or regulation governing the practice of massage therapy shall constitute grounds for further disciplinary action.
