CONSENT ORDER

The Virginia Board of Nursing ("Board") and Amy K. Mock, R.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Mock's license to practice as a professional nurse in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Amy K. Mock, R.N., was issued License No. 0001-174833 to practice as a registered nurse by the Virginia Board of Nursing on July 31, 2001. Said license is set to expire on November 30, 2009.
2. During the course of her employment at a professional nurse at Mary Washington Hospital, Fredericksburg, Virginia, between February and June 2006, she diverted Percocet (oxycodone HCL with Acetaminophen, Schedule III) and in June 2006, Ms. Mock diverted Dilaudid (hydromorphone HCL, Schedule II) from her workplace for her personal and unauthorized use. As a result of the discovery of her diversion, she attended an Intensive Outpatient Program from July 31, 2006 to June 7, 2007.
3. Ms. Mock signed a Participation Contract with the Health Practitioners' Intervention Program ("HPIP") on July 25, 2006, and Recovery Monitoring Contracts with HPIP on August 14, and September 20, 2006, and January 26, April 13, and June 27, 2007. In these contracts she admitted to suffering from opioid dependence.
4. Pursuant to her HPIP contracts, Ms. Mock was required to submit to random urine drug screens. The drug screen conducted on September 10, 2008, produced a positive result for Ultram (tramadol).

HCL, Schedule VI). Ms. Mock attended a 12-week Intensive Outpatient Program until December 12, 2008 and is now attending a once-a-week aftercare program.

CONCLUSIONS OF LAW

1. Finding of Fact No. 2 constitutes a violation of violation of § 54.1-3007(2), (5) and (6) of the Code of Virginia (1950), as amended (“Code”), and 18 VAC 90-20-300(A)(2)(c) of the Board of Nursing Regulations.

2. Findings of Fact Nos. 3 and 4 constitute a violation of § 54.1-3007(6) of the Code

CONSENT

Amy K. Mock, R.N., by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact contained herein and waives her right to contest such Findings of Fact in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her right to practice as a professional nurse in Virginia.

ORDER


WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. The Board shall TAKE NO FURTHER ACTION against Amy K. Mock, R.N., at this time contingent on the following conditions:
 - a. Amy K. Mock shall comply with all terms and conditions for the period specified by the HPIP.
 - b. Any violation of the terms and conditions stated in this Order shall be reason for revoking the license of Ms. Mock, and an administrative proceeding shall be held to determine whether his license shall be revoked. Ms. Mock shall be noticed to appear before the Board at such time as the Board is notified that:
 - i. Ms. Mock is not in compliance with the terms and conditions specified by the HPIP;
 - ii. Ms. Mock's participation in the HPIP has been terminated;
 - iii. There is a pending investigation or unresolved allegation against Ms. Mock involving a violation of law, regulation, or any term or condition of this order.
3. This Order is applicable to Ms. Mock's multistate licensure privileges, if any, to practice as a professional nurse in the Commonwealth of Virginia. For the duration of this Order, Ms. Mock shall not work outside of the Commonwealth of Virginia pursuant to a multistate licensure privilege without the written permission of the Virginia Board of Nursing and the Board of Nursing in the party state where she wishes to work. Any requests for out of state employment should be directed, in writing, to the Executive Director of the Board.

4. Ms. Mock shall maintain a course of conduct in her capacity as a professional nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
