ORDER

JURISDICTION AND PROCEDURAL HISTORY

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), a Special Conference Committee of the Virginia Board of Nursing ("Board") held an informal conference on October 26, 2016, in Henrico County, Virginia, to receive and act upon Camille Monique Swift's application for certification by endorsement to practice as a nurse aide in the Commonwealth of Virginia and to inquire into evidence that grounds may exist to deny said application.

Camille Monique Swift appeared at this proceeding and was not represented by legal counsel.

NOTICE

By letter dated September 2, 2016, the Board sent a Notice of Informal Conference ("Notice") to Ms. Swift notifying her that an informal conference would be held on October 26, 2016. The Notice was sent by certified and first class mail to the legal address of record on file with the Board.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and Conclusions of Law and issues the Order contained herein.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Camille Monique Swift submitted an application for certification by endorsement as a nurse aide in the Commonwealth of Virginia on April 18, 2016. Ms. Swift is certified to practice as a nurse aide in the State of Connecticut.

- 2. Ms. Swift violated Virginia Code § 54.1-3007(4), as evidenced by the fact that in the Geographical Area 12 Court, Manchester, Connecticut, she was convicted of the following crimes of moral turpitude:
- a. On March 31, 2009, Ms. Swift was convicted of one count misdemeanor larceny 6th degree.
- b. On February 2, 1995, Ms. Swift was sentenced for one count misdemeanor larceny 6th degree.
- c. On April 21, 1994, Ms. Swift was sentenced for one count misdemeanor larceny 6th degree.
- 3. At the informal conference Ms. Swift was forthright about her criminal history and stated that she regretted her past mistakes.
- 4. Ms. Swift stated that she had several job prospects and plans to work at Southern Hospice, Hampton, Virginia once she gets her certificate.
- 5. Ms. Swift otherwise meets the requirements of Virginia Code § 54.1-3024 and 18 VAC 90-25-72 of the Regulations Governing Certified Nurse Aides.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. The application of Camille Monique Swift for certification to practice as a nurse aide in the Commonwealth of Virginia is APPROVED.
- 2. Ms. Swift shall comply with all laws and regulations governing nurse aide practice in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
