CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Royshonn Lashae Wheaton-Buckley, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Wheaton-Buckley's application for licensure by examination to practice practical nursing in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Royshonn Lashae Wheaton-Buckley submitted an application for licensure by examination to practice practical nursing in the Commonwealth of Virginia on June 1, 2016.
2. Ms. Wheaton-Buckley violated Virginia Code § 54.1-3007(4) in that on January 28, 2010, she received a special Court Martial by the United States Navy for larceny of more than \$500.00. She was confined for 85 days and forfeited three months of salary.
3. Ms. Wheaton-Buckley violated Virginia Code § 54.1-3007(1) and 18 VAC 90-20-300(A)(1)(b) of the Regulations Governing the Practice of Nursing in that on her application for licensure by examination to practice practical nursing, she answered "NO" to the question "Have you ever been convicted, pled guilty or pled Nolo Contendere to the violation of any federal, state or other statute or ordinance constituting a felony or misdemeanor?" when, in fact, Ms. Wheaton-Buckley was court martialled for larceny, as evidenced in Finding of Fact Number 2.
4. Ms. Wheaton-Buckley otherwise meets the requirements of Virginia Code § 54.1-3020.

CONSENT

Royshonn Lashae Wheaton-Buckley, by affixing her signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;
2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 *et seq.*;
3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;
4. I waive my right to an informal conference;
5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
6. I consent to the entry of the following Order affecting my application for licensure by examination to practice practical nursing in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

1. Royshonn Lashae Wheaton-Buckley is REPRIMANDED.
2. The application of Ms. Wheaton-Buckley for licensure to practice practical nursing in the Commonwealth of Virginia is APPROVED. Upon successful completion of the NCLEX-PN examination, Ms. Wheaton-Buckley shall be issued an unrestricted license to practice practical nursing in the Commonwealth.

3. Royshonn Lashae Wheaton-Buckley shall comply with all laws and regulations governing the practice of practical nursing in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.

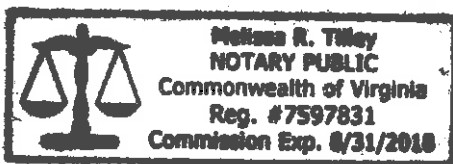
