NOTICE OF FORMAL ADMINISTRATIVE HEARING AND STATEMENT OF ALLEGATIONS

You are hereby notified that a formal hearing has been scheduled before the Board of Nursing ("Board") regarding your application for reinstatement of your license to practice as a licensed practical nurse in the Commonwealth of Virginia following its mandatory suspension by the Department of Health Professions.

LEGAL AUTHORITY AND JURISDICTION:

- 1. This formal hearing is being held pursuant to Virginia Code §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11). This proceeding will be convened as a public meeting pursuant to Virginia Code § 2.2-3700.
- 2. The burden rests on you, as the applicant, to demonstrate that you are prepared to resume the safe and competent practice of practical nursing.
- 3. In considering your application, the Board will consider evidence that grounds may exist to deny your application for reinstatement of your license to practice as a licensed practical nurse, as more fully set out in the enclosed Statement of Allegations.
- 4. At the conclusion of the proceeding, the Board is authorized to take any of the following actions:
- Approve your application and issue an unrestricted license to practice as a licensed practical nurse;
 - Approve your application and issue a restricted license subject to terms and conditions;

- Deny your application;
- Deny your application and continue your license on indefinite suspension or revoke your license.

ABSENCE OF RESPONDENT AND RESPONDENT'S COUNSEL:

If you fail to appear at the formal hearing, the Board may proceed to hear this matter in your absence and may take any of the actions outlined above.

RESPONDENT'S LEGAL RIGHTS:

You have the right to the information on which the Board will rely in making its decision, to be represented by counsel at this proceeding, to subpoena witnesses and/or documents, and to present relevant evidence on your behalf.

COMMONWEALTH'S EXHIBIT:

Enclosed is a copy of the documents that will be distributed to the members of the Board and will be considered by the Board when discussing any allegations with you and when deliberating on your case. These documents are enclosed only with the notice sent by certified mail, which you may be required to claim at the post office. Please bring these documents with you to the formal hearing.

NOTE: Failure to object to the distribution prior to the proceeding will not affect your right to contest any information contained in these documents at the proceeding.

OTHER IMPORTANT INFORMATION:

Pursuant to Virginia Code § 54.1-2409(D), reinstatement of your license requires the affirmative vote of three-fourths of the members of the Board in attendance at the hearing.

STATEMENT OF ALLEGATIONS

The Board of Nursing alleges that grounds exist to refuse to reinstate the license of Harry Asanji Fon, L.P.N. to practice as a licensed practical nurse in that:

- 1. Mr. Fon violated Virginia Code § 54.1-3007(7) in that on or about July 26, 2012, the Oklahoma Board of Nursing suspended his license to practice practical nursing in that state for a period of six months.
- 2. Mr. Fon violated Virginia Code § 54.1-3007(2), (5), and (8) and 18 VAC 90-20-300(A)(2)(f) of the Regulations Governing the Practice of Nursing in that during the course of his employment with Bellevue Care and Rehab Center, Oklahoma City, Oklahoma, on or about March 9, 2011, Mr. Fon failed to perform and document a focused assessment, complete a Facility Incident Report, or notify the physician, Director of Nursing, oncoming nurse, and family members of a facility resident's fall.
