Dear Ms. Blackmon:

Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that your license to practice nursing in the Commonwealth of Virginia has been mandatorily suspended by the enclosed Order entered January 30, 2013. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license or certificate to do so suspended shall be guilty of a felony. Please return your license to Jay P. Douglas, Executive Director of the Virginia Board of Nursing, at the above address, immediately upon receipt of this letter.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your license, and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of sixty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your license shall require the affirmative vote of three-fourths of the members present of the Board of Nursing.

ORDER

In accordance with Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), I, Dianne L. Reynolds-Cane, M.D., Director of the Virginia Department of Health Professions, received and acted upon evidence that the license of Alexandria Denise Blackmon, R.N., to practice as a registered professional nurse in the State of Minnesota was suspended by an Order of Suspension dated January 14, 2013. A certified copy of the Order of Suspension is attached to this Order and is marked as Commonwealth's Exhibit No. 1.

WHEREFORE, by the authority vested in the Director of the Department of Health Professions pursuant to Section 54.1-2409 of the Code, it is hereby ORDERED that the license of Alexandria Denise Blackmon, R.N., to practice as a professional nurse in the Commonwealth of Virginia be, and hereby is, SUSPENDED.

Upon entry of this Order, the license of Alexandria Denise Blackmon, R.N., will be recorded as suspended. Should Ms. Blackmon seek reinstatement of her license pursuant to Section 54.1-2409 of the Code, she shall be responsible for any fees that may be required for the reinstatement and renewal of her license prior to issuance of her license to resume practice.

Pursuant to Sections 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection and copying upon request.

ORDER OF SUSPENSION

WHEREAS, the Minnesota Board of Nursing ("Board") is authorized pursuant to Minnesota Statutes sections 148.171 to 148.285 to license and regulate persons who hold licenses to practice nursing in the State of Minnesota and is further authorized pursuant to Minnesota Statutes sections 214.10 and 214.103 to review complaints against licensed nurses and to initiate appropriate disciplinary action.

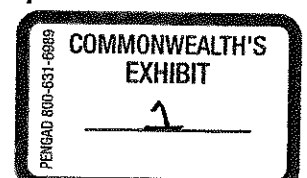
WHEREAS, Alexandria D. Blackmon, R.N. ("Licensee"), has been and is now subject to the jurisdiction of the Board from which she holds a license to practice professional nursing in the State of Minnesota.

WHEREAS, pursuant to Minnesota Statutes section 270.72, subdivision 1, the Board must revoke the license of a nurse upon receipt of notice from the Minnesota Commissioner of Revenue that the nurse owes the state \$500 or more in delinquent taxes, penalties, or interest or has not filed tax returns.

WHEREAS, on December 14, 2012, the Board received a Notice of License Revocation from the Minnesota Commissioner of Revenue, which advised the Board that Licensee has an outstanding tax liability, and under Minnesota Statutes sections 270.72 and 16D.08, subdivision 2, the Board must revoke Licensee's license to practice nursing in the State of Minnesota. Revenue Notice No. 96-1: Collection; Revocation of Licenses; Definition, however, states that the Department of Revenue "deems the term revoke to mean that the taxpayer's license will be *suspended* until the tax obligation has been satisfied and the tax clearance certificate has been issued." (Emphasis added.)

ORDER

I. IT IS HEREBY ORDERED that Licensee's license to practice professional nursing in the State of Minnesota is **SUSPENDED**, effective immediately. During the period of



suspension, Licensee shall not engage in the practice of nursing, as defined by Minnesota Statutes section 148.171, in the State of Minnesota; nor use any abbreviation or other designation tending to imply licensure as a professional or practical nurse pursuant to Minnesota Statutes section 148.281, subdivision 1(4).

2. IT IS FURTHER ORDERED that if Licensee is in possession of her nursing registration certificate, Licensee shall surrender and personally deliver or mail the certificate to the Minnesota Board of Nursing, c/o Shirley A. Brekken, Executive Director, 2829 University Avenue S.E., Suite 200, Minneapolis, Minnesota 55414, within ten days of the date of this Order.

3. IT IS FURTHER ORDERED that the suspension shall remain in effect until such time as the Board receives a tax clearance certificate from the Department of Revenue indicating that Licensee does not owe any delinquent taxes, penalties, or interest and has filed all required returns. In addition, Licensee must comply with the following terms:

a. If Licensee seeks reinstatement of her license within 24 months of the date of this Order, Licensee shall meet all reregistration requirements in effect at the time Licensee seeks reinstatement, including but not limited to submission of the reregistration application form and payment of the reregistration fee.

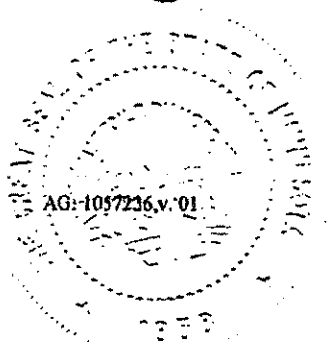
b. If Licensee does not seek reinstatement of her license within 24 months of the date of this Order, Licensee may be required to meet other licensure or reregistration requirements consistent with Minnesota Statutes section 148.171, *et seq.*
