**CONSENT ORDER**

**JURISDICTION AND PROCEDURAL HISTORY**

The Virginia Board of Nursing ("Board") and Carla Cherry, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Cherry's application for licensure by examination to practice professional nursing in the Commonwealth of Virginia.

**FINDINGS OF FACT AND CONCLUSIONS OF LAW**

1. Carla Cherry submitted an application for licensure by examination to practice professional nursing in the Commonwealth of Virginia on June 8, 2016.
2. Ms. Cherry violated Virginia Code § 54.1-3007(4) in that on July 9, 2015, she was convicted of petit larceny in the Albemarle County, Virginia, General District Court.
3. Ms. Cherry provided evidence that she has paid all court costs related to this conviction, and has made restitution.
4. Ms. Cherry otherwise meets the requirements of Virginia Code § 54.1-3017.

**CONSENT**

Carla Cherry, by affixing her signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;
2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 *et seq.*;

3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;

4. I waive my right to an informal conference;

5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;

6. I consent to the entry of the following Order affecting my application for licensure by examination to practice professional nursing in the Commonwealth of Virginia.

### ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:


1. Carla Cherry, is REPRIMANDED.

2. The application of Carla Cherry for licensure by examination to practice professional nursing in the Commonwealth of Virginia is APPROVED. Upon successful completion of the NCLEX-RN examination, Ms. Cherry shall be issued an unrestricted license to practice professional nursing in the Commonwealth.

3. Ms. Cherry shall comply with all laws and regulations governing the practice of professional nursing in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.


