that this decision is served by mail, three days are added to that period.

REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Allison Gregory, M.S., R.N.,

F.N.P.-B.C., serving as Agency Subordinate of the Virginia Board of Nursing ("Board"), held an

informal conference on July 14, 2016 in Henrico County, Virginia, to inquire into evidence that Jessica

K. Haynes, L.P.N. may have violated certain laws and regulations governing the practice of practical

nursing in the Commonwealth of Virginia.

Ms. Haynes did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated June 23, 2016, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms. Haynes notifying her that an informal conference would be held on July 14, 2016.

The Notice was sent by certified and first class mail to the legal address of record on file with the

Board of Nursing. According to the U.S.P.S. tracking website, the Notice sent by certified mail was

refused on June 25, 2016. The package was forwarded on June 27, 2016, but on July 7, 2016, delivery

failed because the recipient had moved and left no address. As of July 13, 2016, the certified mail

package had arrived at the U.S.P.S. facility in Merrifield, Virginia, and it was in transit to its

destination. The Notice sent by first class mail was not returned to the Board office. Accordingly, the

Agency Subordinate concluded that adequate notice was provided to Ms. Haynes and the informal conference proceeded in her absence.

## Recommended Findings of Fact and Conclusions of Law

- 1. Jessica K. Haynes, L.P.N. was issued License Number 0002-086643 to practice practical nursing on February 28, 2012, which is scheduled to expire on October 31, 2017. At all times relevant to the findings herein, said license was in full force and effect. Her primary state of residence is Virginia.
- 2. By order entered February 15, 2012, the Board reprimanded Ms. Haynes and approved her application for licensure by examination as a practical nurse. The Order was based on findings that Ms. Haynes had been convicted of misdemeanor shoplifting.
- 3. Ms. Haynes violated Virginia Code § 54.1-3007(2), (3), (5), and (8) and 18 VAC 90-20-300(A)(2)(c), (f), and (k) of the Regulations Governing the Practice of Nursing ("Regulations") in that in 2015, during the course of her employment with NurseFinders, Charlottesville, Virginia, she diverted multiple medication cards from multiple patients, as evidenced by the following:
- a. While working on a contract at Augusta Nursing and Rehabilitation Center, Ms. Haynes diverted venlafaxine from Resident A, oxybutynin from Resident B, lisinopril from Resident C, and sulfamethoxazole from Patient D.
- b. While working at Fluvanna Correctional Center, Fluvanna, Virginia, Ms. Haynes diverted trazodone (C-IV) from Inmate E.
- 4. The patients' medications were found in Ms. Haynes' possession by a third party, who reported the matter to NurseFinders. Ms. Haynes failed to meet with or provide a statement to her supervisor at NurseFinders during the investigation of these matters. The investigator for the Department of Health Professions ("DHP") noted that Ms. Haynes' employment was terminated as a result of these investigations.

5. Ms. Haynes violated Virginia Code § 54.1-3007(2) and 18 VAC 90-20-300(A)(2)(e) of

the Regulations in that on her application for employment with NurseFinders dated August 29, 2014,

Ms. Haynes listed her reason for leaving employment with the The Lodge at Old Trail, Crozet,

Virginia, as "new job." In fact, Ms. Haynes' employment with The Lodge at Old Trail was terminated

on May 27, 2014.

6. Ms. Haynes failed to respond to numerous contact attempts by the DHP investigator.

She stated in an e-mail to the DHP investigator that she was not sure how driving two hours to meet

with the investigator would "work for her."

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate recommends that the Board issue an Order as follows:

1. The license issued to Jessica K. Haynes, L.P.N. to practice practical nursing in the

Commonwealth of Virginia is INDEFINITELY SUSPENDED.

2. The license of Ms. Haynes will be recorded as SUSPENDED.

3. This suspension applies to any multistate privilege to practice practical nursing.

4. Should Ms. Haynes seek reinstatement of her license, an administrative proceeding

shall be convened to consider such application. At such time, the burden shall be on Ms. Haynes to

demonstrate that she is safe and competent to return to the practice of practical nursing. Ms. Haynes

shall be responsible for any fees that may be required for the reinstatement and/or renewal of the

license prior to issuance of the license to resume practice.
