CONSENT ORDER

The Virginia Board of Nursing ("Board") and Jessica K. Haynes, C.N.A., L.P.N. Applicant, as evidenced by his signature hereto, enter into the following Consent Order affecting Ms. Haynes' application for licensure by examination to practice as a practical nurse and her certificate to practice as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Jessica K. Haynes, C.N.A., was issued Certificate No. 1401-116442 to practice as a nurse aide by the Virginia Board of Nursing on October 31, 2006. Said certificate is set to expire on November 30, 2012. Her primary state of residence is Virginia.
- 2. By application received December 3, 2011, Ms. Haynes applied for licensure by examination as a practical nurse in the Commonwealth of Virginia.
- 3. On October 16, 2008, in the General District Court of Culpeper, Virginia, Ms. Haynes was convicted of shoplifting, a misdemeanor. She was sentenced to 30 days in jail, suspended, placed on probation, and ordered to complete a shoplifting prevention class. Ms. Haynes was also ordered to pay restitution of \$19.96 plus court costs. She successfully completely the period of probation on January 21, 2009.

CONCLUSIONS OF LAW

1. Finding of Fact No. 3 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").

2. The Board concludes that Ms. Haynes otherwise meets the requirements of § 54.1-3020 of the Code.

CONSENT

Jessica K. Haynes, C.N.A., by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her application for licensure by examination as a practical nurse and her certificate to practice as a nurse aide in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. Jessica K. Haynes, C.N.A., is hereby REPRIMANDED.
- 2. The application of Jessica K. Haynes, C.N.A., for licensure by examination as a practical nurse is APPROVED. Upon successful completion of the NCLEX-PN examination, Ms. Haynes shall be issued an unrestricted license to practice as a practical nurse in the Commonwealth.

SEEN AND AGREED TO:

3. Ms. Haynes shall maintain a course of conduct in her capacity as a practical nurse and as a nurse aide commensurate with the requirements of § 54.1-3000 et seq. of the Code, the Regulations Governing the Practice of Nursing and the Regulations Governing Certified Nurse Aides.
