REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Jane Elliott, R.N., Ph.D., serving as

Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal conference on June

23, 2016 in Henrico County, Virginia, to inquire into evidence that Maria Ann Hryhorenko, R.N. may

have violated certain laws and regulations governing the practice of professional nursing in the

Commonwealth of Virginia.

Ms. Hryhorenko did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated May 25, 2016, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms. Hryhorenko notifying her that an informal conference would be held on June 23,

2016. The Notice was sent by certified and first class mail to the legal address of record on file with

the Board of Nursing. The Notice sent by certified mail was signed for and returned to the Board. The

Notice sent by first class mail was not returned to the Board office. Accordingly, the Agency

Subordinate concluded that adequate notice was provided to Ms. Hryhorenko and the informal

conference proceeded in her absence.

## Recommended Findings of Fact and Conclusions of Law

- 1. Maria Ann Hryhorenko, R.N. was issued License Number 0001-244265 to practice professional nursing on May 14, 2013, which is scheduled to expire on September 30, 2016. At all times relevant to the allegations herein, said licenses was in full force and effect. Her primary state of residence is Virginia.
- 2. By Order of the Board entered on June 10, 2015 ("Board's Order"), the Board took no action on Ms. Hryhorenko's license to practice as a professional nurse in Virginia conditioned upon her continued compliance with the Health Practitioners' Monitoring Program ("HPMP"). This Order was based on findings that Ms. Hryhorenko, on several occasions during the course of her employment with Chesapeake Regional Medical Center, Chesapeake, Virginia, from September to October of 2014, diverted narcotic medications for her personal and unauthorized use, and that she had entered the HPMP on January 6, 2015.
- 3. Ms. Hryhorenko violated Virginia Code § 54.1-3007(6) and Term Number 1 of the Board's Order, which required her to comply with all terms and conditions of the HPMP, in that on September 18, 2015, Ms. Hryhorenko was dismissed from the HPMP for continued use of opiates and alcohol, failure to attend treatment as recommended, non-compliance with the toxicology screening program, and failure to maintain communication with the HPMP.
- 4. On November 3, 2015, Ms. Hryhorenko informed an investigator for the Department of Health Professions that she was still using oxycodone.
- 5. On November 3, 2015, Ms. Hryhorenko agreed to a drug screen to be performed by Labcorp, but the investigator for the Department of Health Professions never received notification from Labcorp that a drug screen was performed.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate

recommends that the Board issue an Order as follows:

1. Maria Ann Hryhorenko is REPRIMANDED.

2. The license of Maria Ann Hryhorenko to practice professional nursing in the

Commonwealth of Virginia is INDEFINITELY SUSPENDED.

3. The license of Maria Ann Hryhorenko will be recorded as SUSPENDED.

4. This suspension applies to any multistate privilege to practice professional nursing.

5. Should Maria Ann Hryhorenko seek reinstatement of her license, an administrative

proceeding shall be convened to consider such application. At such time, the burden shall be on Maria

Ann Hryhorenko to demonstrate that she is safe and competent to return to the practice of professional

nursing. Maria Ann Hryhorenko shall be responsible for any fees that may be required for the

reinstatement and/or renewal of the license prior to issuance of the license to resume practice.
