REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Judith Piersall, R.N., B.S.N.,

serving as Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal

conference on June 21, 2016 in Henrico County, Virginia, to inquire into evidence that Vivian Anita

Wallington Raysor, C.N.A. may have violated certain laws and regulations governing the practice of

certified nurse aides in the Commonwealth of Virginia.

Ms. Raysor did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated June 1, 2016, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms. Raysor notifying her that an informal conference would be held on June 21, 2016.

The Notice was sent by certified and first class mail to the legal address of record on file with the

Board of Nursing. The certified mail receipt was signed and returned to the Board office. The Notice

sent by first class mail was not returned to the Board office. Accordingly, the Agency Subordinate

concluded that adequate notice was provided to Ms. Raysor and the informal conference proceeded in

her absence.

Recommended Findings of Fact and Conclusions of Law

- 1. Vivian Anita Wallington Raysor, C.N.A. was issued Certificate Number 1401-108068 to practice as a nurse aide on March 23, 2005, which is scheduled to expire on March 31, 2017. At all times relevant to the allegations herein, said certificate was in full force and effect.
- 2. Vivian Anita Wallington Raysor, C.N.A. violated Virginia Code § 54.1-3007(2), (5), and (8) and 18 VAC 90-25-100(2)(e) of the Regulations Governing Certified Nurse Aides ("Regulations") in that during the course of her employment with the Laurels of Bon Air, Richmond, Virginia, on June 16, 2015, Ms. Raysor cursed at a resident. Further, Ms. Raysor handled the resident roughly and pushed him in his wheelchair into his bed and a radiator. The event was witnessed by a C.N.A. student.
- 3. As a result of this incident, Ms. Raysor's employment with the Laurels of Bon Air was terminated effective June 16, 2015.
- 4. Ms. Raysor violated Virginia Code § 54.1-3007(2) and 18 VAC 90-25-100(2)(d) of the Regulations in that on her application for employment with Envoy of Westover Hills, Richmond, Virginia, dated June 30, 2015:
- a. Ms. Raysor failed to disclose her previous employment with My Home Away from Home, Richmond, Virginia, where she worked between October 25, 2013 and January 29, 2014, when her employment was terminated following several written warnings for multiple medication errors, tardiness, and failure to follow instructions.
- b. Ms. Raysor failed to disclose her "reason for leaving" employment with Sunrise Senior Living, Richmond, Virginia. In fact, Ms. Raysor's employment with Sunrise Senior Living was terminated on June 24, 2013 for abuse or neglect of residents.

5. Ms. Raysor has had six employers since 2012, and her employment with all six

employers was terminated.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate

recommends that the Board issue an Order as follows:

1. The certificate of Ms. Raysor to practice as a nurse aide in the Commonwealth of Virginia

is REVOKED.

2. The certificate of Ms. Raysor will be recorded as REVOKED.

3. A Finding of Abuse shall be ENTERED against Vivian Anita Wallington Raysor in the

Virginia Nurse Aide Registry pursuant to 42 CFR § 483.13(c)(1)(ii)(B) and 42 CFR § 483.156(b)(2)

and (c)(1)(iv)(D). This finding prohibits Vivian Anita Wallington Raysor's employment as a certified

nurse aide in any long-term care facility that receives Medicare or Medicaid reimbursement, according

to 42 CFR § 483.13(c)(1)(ii)(B).
