REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Judith Piersall, R.N., B.S.N.,

serving as Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal

conference on June 21, 2016 in Henrico County, Virginia, to inquire into evidence that Avis A. Baker,

C.N.A. may have violated certain laws and regulations governing the practice of certified nurse aides

in the Commonwealth of Virginia.

Ms. Baker appeared at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated May 23, 2016, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms. Baker notifying her that an informal conference would be held on June 21, 2016.

The Notice was sent by certified and first class mail to the legal address of record on file with the

Board of Nursing.

Recommended Findings of Fact and Conclusions of Law

1. Avis A. Baker, C.N.A. was issued Certificate Number 1401-137978 to practice as a

nurse aide on June 16, 2010, which is scheduled to expire on June 30, 2017. At all times relevant to

the allegations herein, said certificate was in full force and effect.

- 2. Avis A. Baker, C.N.A. violated Virginia Code § 54.1-3007(6) in that she is unsafe to practice as a certified nurse aide due to mental illness, as evidenced by the following:
- a. On June 25, 2015, Ms. Baker was admitted to Tucker Pavilion, Chippenham Johnston- Willis Medical Center, Richmond, Virginia, pursuant to a temporary detention order with a provisional diagnosis of paranoid schizophrenia. She was discharged on July 2, 2015 with a diagnosis of schizoaffective disorder.
- b. Ms. Baker currently sees a licensed psychologist once a week for treatment of anxiety and bipolar disorder, for which she is prescribed medication. On September 15, 2015, her psychologist stated to the investigator for the Department of Health Professions that it seemed unlikely that Ms. Baker will be able to return to practice as a nurse aide. In a letter dated June 13, 2016, the psychologist wrote that "at the present time, her anxiety level although significantly diminished, remains too high" for Ms. Baker to practice as a certified nurse aide.
- 3. Ms. Baker has been certified to practice as a nurse aide since 2010, but she has only worked in private duty settings, which have not required a C.N.A. certificate.
- 4. When speaking to the investigator for the Department of Health Professions on September 17, 2015, Ms. Baker expressed a desire to voluntarily surrender her nurse aide certificate. At the informal conference, Ms. Baker stated that she no longer wished to surrender her certificate and demonstrated a lack of understanding of the process for nurse aide certification and renewal.

## Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate recommends that the Board issue an Order as follows:

1. The certificate issued to Avis A. Baker to practice as a certified nurse aide in the Commonwealth of Virginia is INDEFINITELY SUSPENDED.

prior to issuance of the certificate to resume practice.

2. The certificate of Avis A. Baker will be recorded as SUSPENDED.

3. Should Ms. Baker seek reinstatement of her certificate, an administrative proceeding shall be convened to consider such application. At such time, the burden shall be on Ms. Baker to demonstrate that she is safe and competent to return to the practice as a nurse aide. Ms. Baker shall be responsible for any fees that may be required for the reinstatement and/or renewal of the certificate
