REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Allison Gregory, M.S., R.N., F.N.P.-

B.C., serving as Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal

conference on August 3, 2017 in Henrico County, Virginia, to inquire into evidence that Brandi N.

Eichelberger, R.N., may have violated certain laws and regulations governing the practice of nursing in

the Commonwealth of Virginia.

Ms. Eichelberger did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated June 30, 2017, the Board sent a Notice of Informal Conference ("Notice") to Ms.

Eichelberger notifying her that an informal conference would be held on August 3, 2017. The Notice

was sent by certified and first class mail to the legal address of record on file with the Board. The

certified mail receipt was signed and returned to the Board. The Notice sent by first class mail was not

returned to the Board office. Accordingly, the Agency Subordinate concluded that adequate notice was

provided to Ms. Eichelberger and the informal conference proceeded in her absence.

Recommended Findings of Fact and Conclusions of Law

1. Brandi N. Eichelberger, R.N., was issued License Number 0001-250099 to practice

professional nursing on March 5, 2014, which was valid in Virginia only and which expired on June 30,

- 2017. At all times relevant to the findings herein, said license was in full force and effect. Ms. Eichelberger is also licensed to practice professional nursing in the State of West Virginia. Her primary state of residence is West Virginia.
- 2. By Order entered September 2, 2016 ("Board's Order"), the Board reprimanded Ms. Eichelberger and required her to pay a monetary penalty of \$1,000 and complete three online NCSBN courses within 90 days. This Order was based on findings that while employed at Valley Health System, Winchester, Virginia Ms. Eichelberger had forged a prescription for nitroglycerin for a patient in her care and had signed a physician's name to the prescription without justification or authorization.
- 3. Ms. Eichelberger violated Term No. 2 of the Board's Order, which required her to pay the monetary penalty within 90 days of the entry of the Order, in that she failed to pay the monetary penalty.
- 4. In a letter to the Board dated January 5, 2017, Ms. Eichelberger stated that she had sent a check "to the cashier" to satisfy the monetary penalty, but as of the date of the informal conference, no check had been received. She did not respond to any follow-up contacts by the Board's Compliance Case Manager.
- 5. Ms. Eichelberger violated Term No. 3 of the Board's Order, which required her to provide written proof of completion of three NCSBN courses within 90 days of the Order's entry, or by December 1, 2016, in that she did not submit the certificates of completion until January 12, 2017.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate recommends that the Board issue an Order as follows:

1. Brandi N. Eichelberger, R.N., is REPRIMANDED.

2. The right of Brandi N. Eichelberger, R.N., to renew her license to practice professional

nursing in the Commonwealth of Virginia is INDEFINITELY SUSPENDED.

3. The license of Brandi N. Eichelberger, R.N., will be recorded as SUSPENDED.

4. This suspension applies to any multistate privilege to practice professional nursing.

5. Should Brandi N. Eichelberger, R.N., seek reinstatement of her license, an administrative

proceeding shall be convened to consider such application. At such time, the burden shall be on Ms.

Eichelberger to demonstrate that she is safe and competent to return to the practice of nursing. Ms.

Eichelberger shall be responsible for any fees that may be required for the reinstatement and/or renewal

of the license prior to issuance of the license to resume practice.
