CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Deborah S. Burnette, R.N., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Burnette's license to practice professional nursing in the Commonwealth of

Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Deborah S. Burnette, R.N. was issued License Number 0001-214156 to practice professional nursing on July 17, 2008, which is scheduled to expire on August 31, 2017. Her primary

state of residence is Virginia.

2. Ms. Burnette violated Virginia Code § 54.1-3007(2), (5) and (6) and 18 VAC 90-20-

300(A)(2)(c) of the Regulations Governing the Practice of Nursing ("Regulations") in that during the

course of her employment with VCU Health Systems, Richmond, Virginia, on June 6 and June 10, 2015,

she withdrew two Prozac (fluoxetine) 20mg tablets from the Pyxis machine for her personal and

unauthorized use and ingested them while on duty. She had been prescribed Prozac to treat her anxiety

and depression, and attributed her diversion of the medication to a "lapse in judgment" due to "extreme

stress."

3. Ms. Burnette violated Virginia Code § 54.1-3007(2) and 18 VAC 90-20-300(A)(2)(e) of

the Regulations in that on her application for employment with Henrico Doctors' Hospital Forest Campus,

Richmond, Virginia, dated July 15, 2015, she wrote that she left employment with VCU Health Systems due to "seeking a new and challenging career opportunity." In fact, she resigned from her position in lieu of termination on or about June 30, 2015 as a result of the incident in Finding of Fact No. 2.

CONSENT

Deborah S. Burnette, R.N., by affixing her signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document; I am represented by Michael Goodman, Esquire and Eileen Talamante, Esquire;
- 2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
 - I waive all right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my right to practice professional nursing in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

1. Deborah S. Burnette is REPRIMANDED.

2. Within 60 days from the date of entry of this Order, Deborah S. Burnette shall provide

written proof satisfactory to the Board of successful completion of the following NCSBN course:

Ethics of Nursing Practice.

3. Deborah S. Burnette shall comply with all laws and regulations governing the practice

of professional nursing in the Commonwealth of Virginia.

4. Any violation of the foregoing terms and conditions of this Order or any statute or

regulation governing the practice of professional nursing shall constitute grounds for further

disciplinary action.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall

remain in the custody of the Department of Health Professions as a public record, and shall be made

available for public inspection and copying upon request.
