### CONSENT ORDER

### JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Sharell Tara McGhee, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. McGhee's application for registration by examination to practice as a medication aide in the Commonwealth of Virginia.

# FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Sharell Tara McGhee submitted an application for registration by examination to practice as a medication aide in the Commonwealth of Virginia on June 8, 2016.
- 2. Ms. McGhee violated Virginia Code § 54.1-3007(4) in that on July 10, 2010, she was convicted of misdemeanor shoplifting in the Albemarle County, Virginia, General District Court.
  - 3. Ms. McGhee otherwise meets the requirements of Virginia Code §54.1-3042.

#### CONSENT

Sharell Tara McGhee, by affixing her signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;

- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
  - 4. I waive all right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for registration by examination to practice as a medication aide in the Commonwealth of Virginia.

#### **ORDER**

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. Sharell Tara McGhee is REPRIMANDED.
- 2. The application of Ms. McGhee for registration to practice as a medication aide in the Commonwealth of Virginia is APPROVED. Upon successful completion of the medication aide examination, Ms. McGhee shall be issued an unrestricted registration to practice as a medication aide in the Commonwealth.
- 3. Ms. McGhee shall comply with all laws and regulations governing the practice as a registered medication aide in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
