ORDER

JURISDICTION AND PROCEDURAL HISTORY

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), a Special Conference Committee of

the Virginia Board of Nursing ("Board") held an informal conference on August 1, 2016, in Henrico

County, Virginia, to inquire into evidence that Ashley E. Bowers, L.P.N., may have violated certain

laws and regulations governing the practice of practical nursing in the Commonwealth of Virginia.

Ashley E. Bowers, L.P.N. did not appear at this proceeding and was not represented by legal

counsel.

NOTICE

By letter dated July 7, 2016, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms. Bowers notifying her that an informal conference would be held on August 1, 2016.

The Notice was sent by certified and first class mail to the legal address of record on file with the

Board of Nursing. The certified mail receipt was signed and returned to the Board office on July 13,

2016. The Notice sent by first class mail was returned to the Board office on July 19, 2016 marked

"return to sender." Accordingly, the Committee Chair concluded that adequate notice was provided to

Ms. Bowers and the informal conference proceeded in her absence.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and

Conclusions of Law and issues the Order contained herein.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Ashley E. Bowers, L.P.N. was issued License Number 0002-074234 to practice practical nursing on August 28, 2006, which is scheduled to expire on July 31, 2017. At all times relevant to the findings contained herein, said license was in full force and effect. Her primary state of residence is Virginia.
- 2. Ms. Bowers violated Virginia Code § 54.1-3007(2), (5) and (8) and 18 VAC 90-20-300(A)(2)(f) of the Regulations Governing the Practice of Nursing in that during the course of her employment with Trustient, on August 6, 2015, Ms. Bowers abandoned Patient A, who has amyotrophic lateral sclerosis and is ventilator dependent, bedridden, and fed through a g-tube, by leaving the patient unattended and failing to return or arrange for continuity of care.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. Ashley E. Bowers is REPRIMANDED.
- 2. Within 60 days from the date of entry of this Order, Ashley E. Bowers shall provide written proof satisfactory to the Board of successful completion of the following NCSBN courses:
 - a. Professional Accountability & Legal Liability for Nurses; and
 - b. Righting a Wrong: Ethics and Professionalism in Nursing.
- 3. Ashley E. Bowers shall comply with all laws and regulations governing the practice of practical nursing in the Commonwealth of Virginia.
- 4. Any violation of the foregoing terms and conditions of this Order or any statute or regulation governing the practice of practical nursing shall constitute grounds for further disciplinary action
