CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Carolyn Diane Holley, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Holley's application for certification by endorsement to practice as a nurse aide in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Carolyn Diane Holley was issued Certificate No. 323304 by the North Carolina Board of Nursing to practice as a nurse aide on May 11, 2005. Said certificate is scheduled to expire on April 30, 2017.
- 2. Carolyn Diane Holley submitted an application for certification by endorsement to practice as a nurse aide in the Commonwealth of Virginia on April 13, 2016.
- 3. Ms. Holley violated Virginia Code § 54.1-3007(4) in that she was convicted of three misdemeanors involving moral turpitude in the Bertie County, North Carolina General Court of Justice, as evidenced by the following:
 - a. On February 7, 1991, Ms. Holley was convicted of shoplifting.
 - b. On August 6, 1996, Ms. Holley was convicted of forgery of an instrument.
- c. On January 20, 2010, Ms. Holley was convicted of providing false information to an officer.
 - 4. Ms. Holley otherwise meets the requirements of Virginia Code §54.1-3024.

CONSENT

Carolyn Diane Holley, by affixing her signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me or my certification except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
 - I waive all right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for certification by endorsement to practice as a nurse aide in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. Carolyn Diane Holley is REPRIMANDED.
- 2. The application of Carolyn Diane Holley for certification by endorsement to practice as a nurse aide in the Commonwealth of Virginia is APPROVED. Carolyn Diane Holley shall be issued an unrestricted certification.

3. Carolyn Diane Holley shall comply with all laws and regulations governing the practice of certified nurse aides in the Commonwealth of Virginia.
