AMENDED REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Allison Gregory, MS., R.N., F.N.P.-

B.C., serving as Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal

conference on May 26, 2016 in Henrico County, Virginia, to inquire into evidence that SHANNON J.

WASHINGTON, L.P.N. may have violated certain laws and regulations governing the practice of

practical nursing in the Commonwealth of Virginia.

Ms. Washington did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated May 3, 2016, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms. Washington notifying her that an informal conference would be held on May 26,

2016. The Notice was sent by certified and first class mail to the legal address of record on file with

the Board of Nursing. The Notice sent by certified mail was returned to the Board marked "Unable to

Forward." As of May 26, 2016, the Notice sent by first class mail was not returned to the Board office.

Accordingly, the Agency Subordinate concluded that adequate notice was provided to Ms. Washington

and the informal conference proceeded in her absence.

Recommended Findings of Fact and Conclusions of Law

- Shannon J. Washington, L.P.N. was issued License Number 0002-063262 to practice practical nursing on February 21, 2002, which is scheduled to expire on July 31, 2018. At all times relevant to the allegations herein, said license was in full force and effect. Her primary state of residence is Virginia.
- 2. Ms. Washington violated Virginia Code § 54.1-3007(2), (5), (8) and 18 VAC 90-20-300(A)(2)(c) and (e) of the Regulations Governing the Practice of Nursing in that during the course of her employment with The Laurels of University Park, Richmond, Virginia, she diverted narcotic medications for her own personal and unauthorized use, as evidenced by the following:
- a. On July 6, 2015, Ms. Washington forged the signature of Nurse A as a witness to wasting Resident B's hydromorphone (C-II) on the Controlled Medication Reconciliation Sheet, when, in fact, Nurse A did not work that day.
- b. Between July 10, 2015 and July 24, 2015, Ms. Washington documented that she withdrew oxycodone (C-II) for Resident B nine times on the Controlled Medication Reconciliation Sheet, but failed to document the administration and pain level on the resident's Medication Administration Record ("MAR"). Further, on July 7, 2015, Ms. Washington had documented that the medication had been discontinued on the MAR.
- C. On July 14, 2015, and July 17, 2015, Ms. Washington forged the signature of Nurse A as a witness to wasting Resident C's hydromorphone on the Controlled Medication Reconciliation Sheet, when, in fact Nurse A did not work either day. Further, on July 6, 2015, Ms. Washington forged Nurse A's signature on Resident C's Controlled Medication Reconciliation Sheet, documenting that Nurse A administered four doses of hydromorphone to Resident C.

3. On September 19, 2015, Ms. Washington's employment with The Laurels of University

Park was terminated. Ms. Washington was disciplined five times for medication and documentation

issues during her employment.

4. Ms. Washington did not respond to the requests for an interview from the investigator

for the Department of Health Professions.

5. Ms. Washington had previously been reprimanded by the Board in 2011 for a

medication documentation issue.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate

recommends that the Board issue an Order as follows:

1. The license issued to Shannon J. Washington to practice practical nursing in the

Commonwealth of Virginia is INDEFINITELY SUSPENDED.

2. The license of Shannon J. Washington will be recorded as SUSPENDED.

3. This suspension applies to any multistate privilege to practice practical nursing.

4. Should Shannon J. Washington seek reinstatement of her license, an administrative

proceeding shall be convened to consider such application. At such time, the burden shall be on

Shannon J. Washington to demonstrate that she is safe and competent to return to the practice of

practical nursing. Shannon J. Washington shall be responsible for any fees that may be required for the

reinstatement and/or renewal of the license prior to issuance of the license to resume practice.
