AMENDED REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Jane Elliott, R.N., Ph.D., serving as

Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal conference on June

1, 2016 in Henrico County, Virginia, to inquire into evidence that Julie Kearchner Carr, R.N. may have

violated certain laws governing the practice of professional nursing in the Commonwealth of Virginia.

Ms. Carr appeared at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated April 26, 2016, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms. Carr notifying her that an informal conference would be held on June 1, 2015. The

Notice was sent by certified and first class mail to the legal address of record on file with the Board of

Nursing.

Recommended Findings of Fact and Conclusions of Law

1. Julie Kearchner Carr, R.N. was issued License Number 0001-207498 to practice

professional nursing on June 26, 2007, which is scheduled to expire on May 31, 2017. At all times

relevant to the allegations herein, said license was in full force and effect. Her primary state of

residence is Virginia.

- 2. Julie Kearchner Carr, R.N. violated Virginia Code § 54.1-3007(6) in that she is unsafe to practice professional nursing due to substance abuse and/or mental and/or physical illness, as evidenced by the following:
- a. On September 12, 2015, Ms. Carr was hospitalized at C.J.W. Medical Center, Richmond, Virginia, for depressive disorder but left against medical advice.
- b. On February 12, 2016 and December 18, 2015, during interviews with a Department of Health Professions investigator, Ms. Carr's psychiatrist and therapist reported that Ms. Carr was unable to return to practice.
- c. Ms. Carr reported sustaining a back injury in 2010 and that she is prescribed oxycodone 20mg (C-II) for back pain. Ms. Carr stated that she takes a minimum of two tablets a day.
  - 3. Ms. Carr was also diagnosed with bipolar disorder in 2012.
- 4. Ms. Carr reported having some improvement with her mental health; however, she feels that she is currently unable to work because she has social anxiety and has difficulty going out in public and talking to strangers. Ms. Carr exhibited a flat affect during the informal conference. She is on long-term disability and out of work until September 2016.
- 5. Ms. Carr reported that she has changed her mental health practitioners and has an appointment with her new therapist on June 2, 2016.
- 6. Ms. Carr had a transient ischemic attack in 1999. She was recently referred for a neurological evaluation, but has failed to follow through on this recommendation.
- 7. Ms. Carr has held two nursing positions since being licensed in 2007. She last practiced at Patient First, Colonial Heights, Virginia, from February 2012 to December 2015.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate

recommends that the Board issue an Order as follows:

1. The license issued to Julie Kearchner Carr to practice professional nursing in the

Commonwealth of Virginia is INDEFINITELY SUSPENDED.

2. The license of Julie Kearchner Carr will be recorded as SUSPENDED.

This suspension applies to any multistate privilege to practice professional nursing.

4. Should Julie Kearchner Carr seek reinstatement of her license, an administrative

proceeding shall be convened to consider such application. At such time, the burden shall be on Julie

Kearchner Carr to demonstrate that she is safe and competent to return to the practice of professional

nursing. Julie Kearchner Carr shall be responsible for any fees that may be required for the

reinstatement and/or renewal of the license prior to issuance of the license to resume practice.
