- 4. At the conclusion of the proceeding, the Committee is authorized to take any of the following actions:
 - Approve your application and issue an unrestricted license to practice practical nursing.
- Approve your application and issue a reprimand, a monetary penalty, and/or a restricted license subject to terms and conditions.
 - Deny your application;

STATEMENT OF ALLEGATIONS

The Board alleges that grounds exist to refuse to reinstate the license of Steva Hairston to practice practical nursing in that:

1. Steva Hairston violated Virginia Code § 54.1-3007(2) and 18 VAC 90-119-230(A)(2)(e) of the Regulations Governing the Practice of Nursing in that on the application for employment with The Madeline Center, Danville, Virginia, submitted in or about July 2017, Ms. Hairston indicated that she had a nursing degree and answered "yes" to the question, are you licensed or license-eligible; however, she failed to reveal that her license had been suspended.
