## NOTICE OF FORMAL ADMINISTRATIVE HEARING AND STATEMENT OF ALLEGATIONS

You are hereby notified that a formal hearing has been scheduled before the Board of Nursing ("Board") regarding your application for reinstatement of your certificate to practice as a certified nurse aide in the Commonwealth of Virginia following its mandatory suspension by the Department of Health Professions.

TYPE OF PROCEEDING:	This is a formal administrative hearing before a panel of the Board of Nursing.

### LEGAL AUTHORITY AND JURISDICTION:

- 1. This formal hearing is being held pursuant to Virginia Code §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11). This proceeding will be convened as a public meeting pursuant to Virginia Code § 2.2-3700.
- 2. The burden rests on you, as the applicant, to demonstrate that you meet the requirements of Virginia Code § 54.1-2409(D).
- 3. In considering your application, the Board will consider evidence that grounds may exist to deny your application for reinstatement of your certificate to practice as a certified nurse aide, as more fully set out in the enclosed Statement of Allegations.
- 4. At the conclusion of the proceeding, the Board is authorized to take any of the following actions:
- Approve your application and issue an unrestricted certificate to practice as a certified nurse aide;

- Approve your application and issue a restricted certificate subject to terms and conditions;
  - Deny your application;
  - Deny your application and continue your certificate on indefinite suspension or revoke your certificate.

### ABSENCE OF RESPONDENT AND RESPONDENT'S COUNSEL:

If you fail to appear at the formal hearing, the Board may proceed to hear this matter in your absence and may take any of the actions outlined above.

#### RESPONDENT'S LEGAL RIGHTS:

You have the right to the information on which the Board will rely in making its decision, to be represented by counsel at this proceeding, to subpoena witnesses and/or documents, and to present relevant evidence on your behalf.

#### **COMMONWEALTH'S EXHIBIT:**

Enclosed is a copy of the documents that will be distributed to the members of the Board and will be considered by the Board when discussing any allegations with you and when deliberating on your case. These documents are enclosed <u>only</u> with the notice sent by certified mail, which you may be required to claim at the post office. Please bring these documents with you to the formal hearing.

- 2. Deadline for filing motions, including requests for continuance or objections to exhibits, in writing, to Darlene Graham at the above address: July 5, 2016. NOTE: Failure to object to the distribution prior to the proceeding will not affect your right to contest any information contained in these documents at the proceeding.

#### OTHER IMPORTANT INFORMATION:

Pursuant to Virginia Code § 54.1-2409(D), reinstatement of your certificate requires the affirmative vote of three-fourths of the members of the Board in attendance at the hearing.

#### STATEMENT OF ALLEGATIONS

The Board of Nursing alleges that grounds exist to refuse to reinstate the certificate of Jacqueline Faye Reed Coles, C.N.A. to practice as a certified nurse aide in that:

- 1. Jacqueline Faye Reed Coles, C.N.A., violated Virginia Code §54.1-3007(4) in that, on January 6, 2016, in the Circuit Court for the County of Danville. Virginia, Ms. Coles was convicted and sentenced on two felony counts of Grand Larceny for her submission of false timesheets while employed by P.B.J.G. Inc., a home care provider. Pursuant to Virginia Code §54.1-2409, this conviction formed the basis for the mandatory suspension of her certificate by Order of the Department of Health Professions entered March 16, 2016.
- 2. Ms. Coles violated Virginia Code §54.1-3007(2) and 18 VAC 90-25-100(2)(d) of the Regulations Governing Certified Nurse Aides ("Regulations") in that, between October 1, 2014 and May 31, 2015, during the course of her employment with P.B.J.G. Inc., a home care provider and sister company of Commonwealth Home Nursing and Hospice, Inc. ("CHNH"), she submitted timesheets for days she had not worked.
- 3. Ms. Coles violated Virginia Code §54.1-3007(2) and 18 VAC 90-25-100(2)(d) of the Regulations Governing Certified Nurse Aides ("Regulations") in that she falsely represented facts on employment applications, as evidenced by the following:
- a. On May 26, 2015, on her employment application for Prince Charles Home Health Care Agency, Ms. Coles falsely claimed her reason for leaving CHNH was "A very bad misunderstanding" when, in fact, her employment with CHNH had been terminated for her falsification of timesheets.

b. On February 4, 2016, on her employment application for Blue Ridge Rehab Center, Ms. Coles falsely claimed her reason for leaving both CHNH and Roman Eagle Rehabilitation ("RER") was "because of a court case" when, in fact, her employment had been terminated from CHNH for her falsification of timesheets, and from RER for failing to keep RER apprised of her legal status following her felony convictions.
