IN RE: ASHLEY D. BROUILLARD, R.N. APPLICANT

CONSENT ORDER

The Virginia Board of Nursing ("Board") and Ashley D. Brouillard, R.N. Applicant, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Brouillard's application for licensure by examination to practice professional nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. By application received April 19, 2010, Ashley D. Brouillard applied for licensure by examination as a registered nurse in the Commonwealth of Virginia.
2. On April 21, 2005, in the General District Court of Isle of Wight County, Virginia, Ms. Brouillard was convicted of driving while under the influence, a misdemeanor. She was sentenced to 30 days in jail, suspended, fined \$250 and ordered to complete the Virginia Alcohol Safety Action Program ("VASAP"). Ms. Brouillard paid all fines and reported that she successfully completed the VASAP.
3. On August 28, 2007, in the General District Court of Newport News, Virginia, Ms. Brouillard was convicted of driving while under the influence, a misdemeanor. She was sentenced to 365 days in jail, with 335 days suspended, fined \$1000 with \$500 suspended, ordered to pay a civil remedial fee of \$750, placed on probation for three years, and ordered to complete the VASAP. Ms. Brouillard submitted documentation of payment of all fines and court costs, and reported that she successfully completed the VASAP.

CONCLUSIONS OF LAW

1. Findings of Fact No. 2 and 3 constitute a violation of § 54.1-3007(6) of the Code of Virginia (1950), as amended (“Code”).
2. The Board concludes that Ms. Brouillard otherwise meets the requirements of § 54.1-3017 of the Code.

CONSENT

Ashley D. Brouillard, R.N. Applicant, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact contained herein and waives her right to contest such Findings of Fact in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her application for licensure to practice professional nursing in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:


1. Ashley D. Brouillard, R.N. Applicant, is hereby REPRIMANDED.

2. The application of Ashley D. Brouillard, R.N. Applicant, for licensure by examination is hereby APPROVED. Upon successful completion of the NCLEX-RN examination, Ms. Brouillard shall be issued an unrestricted license to practice as a professional nurse in the Commonwealth.

3. Ms. Brouillard shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.




