Pursuant to Virginia Code § 54.1-2409, you are hereby given notice that your license and your multistate privilege to practice professional nursing in the Commonwealth of Virginia have been mandatorily suspended by the enclosed Order entered July 27, 2016. You are hereby advised that you may not practice professional nursing or hold yourself out as a licensed professional nurse unless and until the Board of Nursing has notified you in writing that your license or privilege has been reinstated. Please return your license to Jay Douglas, Executive Director of the Virginia Board of Nursing ("Board"), at the above address, immediately upon receipt of this letter.

You may apply to the Board for reinstatement of your license, and you shall be entitled to a formal administrative hearing not later than the next regular meeting of the Board after the expiration of 60 days from the Board's receipt of your reinstatement application. The reinstatement of your license shall require the affirmative vote of three-fourths of the members of the Board present at the hearing. Department of Health Professions, received and acted upon evidence that the license of Jessica Renee Harrison,

R.N. to practice professional nursing in the State of Colorado was suspended by the Colorado State Board of

ORDER OF SUSPENSION PURSUANT TO SECTION 12-38-131(4), C.R.S.

IN THE MATTER OF THE LICENSE TO PRACTICE AS A PROFESSIONAL NURSE IN THE STATE OF COLORADO OF JESSICA RENEE HARRISON, RN LICENSE NUMBER 1628732,

TO: Jessica Renee Harrison, RN ("Respondent")

Pursuant to section 12-38-131(4), C.R.S., Respondent's license to practice as a professional nurse in the State of Colorado is hereby suspended by the State Board of Nursing ("Board"), effective July 6, 2016 based upon the following:

- Respondent was licensed to practice as a professional nurse in the State of Colorado on or about August 5, 2014, and was issued license number 1628732. Respondent has been licensed at all relevant times therein and is now so licensed.
- Effective March 9, 2016, Respondent and the Board entered into a Stipulation and Final Agency Order (Stipulation) in lieu of a formal disciplinary hearing. The Stipulation allowed Respondent to participate in the Nursing Peer Health Assistance or Nurse Alternative to Discipline Program, administered by Peer Assistance Services ("PAS"). The conditions of the Stipulation were imposed pursuant to the authority of section 12-38-116.5(4)(c)(III), C.R.S.
- Respondent agreed to be bound by the terms and conditions set forth in the Stipulation which is fully incorporated herein by this reference.
- Respondent's contract with Peer Assistance Services was effective on April 4, 2016 and required her to:

Abstain from mind and mood altering drugs/substances/alcohol; obtain written verification from all health care providers stating s/he has been notified of Respondent's illness of alcoholism, addiction, physical or psychological problem; discuss all prescription and over-the-counter drugs with the PAS Program Case Manager; provide copies of all prescriptions and the Provider Verification Form to her Case Manager within 24 hours of receipt of prescription; maintain regular contact with assigned Program Case Manager as determined by PAS; provide written verification of completion of a physical examination annually; submit her Colorado State Board of Pharmacy Prescription Drug Monitoring Program (PDMP) report to PAS every six months; obtain and complete the necessary consent forms for Release of Confidential Information between all treatment providers, employers, sponsors, emergency contacts, and regulatory agencies; keep consent forms current; inform PAS of any crimes, criminal arrests, citations, deferred sentences and convictions or complaints

filed with the Board within 24 hours of her knowledge of the complaint; attend all appointments, therapy sessions, meetings, and/or groups, and submit reports or attendance verification as determined by PAS; submit random urine drug screens and/or random Breath, Body fluids, or Hair Analysis as required by PAS; adhere to the PAS Travel Policy, practice requirements and a Return to Work agreement; complete and comply with a Relapse Prevention Plan; and submit monthly self-status reports.

- On May 19, 2016, the Board received information from Peer Assistance Services that Respondent failed to attend or complete the program for the following reasons:
 - a. Respondent did not call the Sentry UA testing line on three occasions, between 4/4/16 and 5/16/18.
 - b. Respondent submitted two dilute urine drug tests between 4/4/16 and 5/16/16.
 - c. Respondent was arrested for a DUI on 5/11/16, with a reported BAC at the time of her arrest of .239.

Respondent has demonstrated repeated instances of non-compliance and a lack of commitment to her rehabilitation as documented by the above instances of non-compliance. Respondent has failed to comply with the terms and conditions outlined in her PAS Rehabilitation Contract. Without her full cooperation, PAS is unable to assure that she is capable of practicing nursing with reasonable skill and safety to patients in her care.

6. Respondent thereby failed to comply with the March 9, 2016 Stipulation and Final Agency Order.

THEREFORE IT IS ORDERED, in accordance with section 12-38-131(4), C.R.S., that the license to practice professional nursing of Jessica Renee Harrison is suspended effective 5:00 p.m., July 7, 2016. Any such suspension shall remain in effect until lifted by the Board. The Board shall lift the suspension upon review of evidence establishing that Respondent has resumed compliance with the March 9, 2016 Stipulation and Final Agency Order.

COMMENCING AT 5:00 P.M. ON JULY 7, 2016, RESPONDENT SHALL NOT ENGAGE IN OR PERFORM ANY ACT REQUIRING A COLORADO LICENSE TO PRACTICE PROFESSIONAL NURSING.
