REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Nancy Durrett, R.N., M.S., serving

as Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal conference on

June 16, 2016 in Henrico County, Virginia, to inquire into evidence that Michelle Knight MacRoberts

Sampsel, C.N.A. may have violated certain laws and regulations governing the practice of nurse aides

in the Commonwealth of Virginia.

Ms. Sampsel did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated May 18, 2016, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms. Sampsel notifying her that an informal conference would be held on June 16, 2016.

The Notice was sent by certified and first class mail to the legal address of record on file with the

Board of Nursing. The Notice sent via certified mail was returned to the Board office on June 2, 2016,

marked "Unable to Forward/Return to Sender". The Notice sent via first class mail was not returned to

the Board office. Accordingly, the Agency Subordinate concluded that adequate notice was provided

to Ms. Sampsel and the informal conference proceeded in her absence.

Recommended Findings of Fact and Conclusions of Law

- 1. Michelle Knight MacRoberts Sampsel, C.N.A. was issued License Number 1401-171351 to practice as a nurse aide on January 9, 2015, which is scheduled to expire on January 31, 2017. At all times relevant to the allegations herein, said certificate was in full force and effect.
- 2. Ms. Sampsel violated Virginia Code § 54.1-3007(5) in that during the course of her employment with Skyline Nursing and Rehabilitation Center, Floyd, Virginia:
- a. In April 2015, she spoke inappropriately to Resident A when telling her to be quiet.
- b. In April 2015, she failed to provide Resident B with privacy while caring for the resident.
- 3. Ms. Sampsel's employment with Skyline Nursing and Rehabilitation Center was terminated following an investigation that concluded the allegations were substantiated. Ms. Sampsel denied the allegation regarding Resident A.
- 4. Ms. Sampsel violated Virginia Code § 54.1-3007(5) in that during the course of her employment with Heritage Hall, Blacksburg, Virginia, in July 2015, she used inappropriate language in the presence of a resident.
 - 5. Ms. Sampsel's employment with Heritage Hall was terminated.
- 6. Ms. Sampsel violated Virginia Code § 54.1-3007(2) and 18 VAC 90-25-100(2)(d) of the Regulations Governing Certified Nurse Aides in that on her May 8, 2015, application for employment with Heritage Hall, she failed to disclose her previous employment with Skyline Health and Rehabilitation Center or that it had been terminated.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate recommends that the Board issue an Order as follows:

- 1. Michele Knight MacRoberts Sampsel, C.N.A., is REPRIMANDED.
- 2. Michelle Knight MacRoberts Sampsel shall comply with all laws and regulations governing the practice of nurse aides in the Commonwealth of Virginia.
