REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Nancy Durrett, R.N., M.S., serving

as Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal conference on

May 10, 2016 in Henrico County, Virginia, to inquire into evidence that Sheila Yvonne Breeding

Gibson, L.P.N. may have violated terms and conditions imposed on her license to practical nursing in

the Commonwealth of Virginia.

Ms. Gibson did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated April 20, 2016, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms. Gibson notifying her that an informal conference would be held on May 10, 2016.

The Notice was sent by certified and first class mail to the legal address of record on file with the

Board of Nursing. According to the United States Postal Service, the Notice sent by certified mail

arrived in Dungannon, Virginia, on April 23, 2016, and was forwarded to Las Vegas, Nevada. As of

May 10, 2016, the notice sent by first class mail was not returned to the Board office. Accordingly,

the Agency Subordinate concluded that adequate notice was provided to Ms.Gibson and the informal

conference proceeded in her absence.

Recommended Findings of Fact and Conclusions of Law

- 1. Sheila Yvonne Breeding Gibson, L.P.N. was issued License Number 0002-109602 to practice practical nursing on April 29, 1999, which expired on March 31, 2015. Her primary state of residence is Virginia.
- 2. By Order of the Board entered October 15, 2004, Ms. Gibson was place on probation, subject to terms and conditions due to findings of poor nursing practice. On March 31, 2007, Ms. Gibson's license to practice practical nursing expired. Order entered August 9, 2007, her right to renew her license was indefinitely suspended. This action was the result of Ms. Gibson's failure to comply with the terms and conditions of her Board Order entered October 15, 2007. By Board's Order entered September 21, 2012, Ms. Gibson's license to practice practical nursing was reinstated and she was placed on probation subject to terms and conditions.
- 3. Sheila Yvonne Breeding Gibson, L.P.N., violated Term Number 2(f) of the Board's Order entered September 21, 2012, which required her to submit quarterly reports to the Board by the last day of the months of March, June, September and December. Ms. Gibson failed to submit reports due June 30, 2015, September 30, 2015, and December 31, 2015.
- 4. Ms. Gibson failed to respond to multiple attempts for an interview by the Board's Compliance Case Manager.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate recommends that the Board issue an Order as follows:

- 1. Sheila Yvonne Breeding Gibson is REPRIMANDED.
- 2. The right of Sheila Yvonne Breeding Gibson to renew her license to practice practical nursing in the Commonwealth of Virginia is INDEFINITELY SUSPENDED.

- 3. The license of Sheila Yvonne Breeding Gibson will be recorded as SUSPENDED.
- 4. This suspension applies to any multistate privilege to practice practical nursing.
- 5. Should Sheila Yvonne Breeding Gibson seek reinstatement of her license, an administrative proceeding shall be convened to consider such application. At such time, the burden shall be on Sheila Yvonne Breeding Gibson to demonstrate that she is safe and competent to return to the practice of practical nursing. Sheila Yvonne Breeding Gibson shall be responsible for any fees that may be required for the reinstatement and/or renewal of the license prior to issuance of the license to resume practice.
