CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Ashley Lynn Carter, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Carter's application for certification by endorsement to practice as a nurse aide in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- Ashley Lynn Carter submitted an application for certification by endorsement to practice as a nurse aide in the Commonwealth of Virginia on March 10, 2016. Ms. Carter holds Certification No. 366849 to practice as a nurse aide in the state of North Carolina. Said certificate is scheduled to expire on March 31, 2018.
- 2. Ms. Carter violated Virginia Code § 54.1-3007(4) in that on October 26, 2015 in the Circuit Court for the County of Rockingham, North Carolina, Ms. Carter was convicted of misdemeanor larceny, a misdemeanor involving moral turpitude.
 - 4. Ms. Carter otherwise meets the requirements of Virginia Code § 54.1-3024.

CONSENT

Ashley Lynn Carter, by affixing her signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;

- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
 - 4. I waive all right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for certification to practice as a nurse aide in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. The application of Ashley Lynn Carter for certification to practice as a nurse aide in the Commonwealth of Virginia is APPROVED Ms. Carter shall be issued an unrestricted certificate.
 - 2. Ms. Carter is REPRIMANDED.
- 3. Ms. Carter shall comply with all laws and regulations governing the practice of certified nurse aides in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
