ORDER

Now comes the Virginia Board of Nursing ("Board") and David Matney, R.N., as evidenced by the signature affixed below, enter into this Order affecting the license of Mr. Matney to practice professional nursing in the Commonwealth of Virginia.

FINDINGS OF FACT

After consideration of the evidence and statements concerning the allegations, the Committee makes the following Findings of Fact:

1. David Matney, R.N., was issued License No. 0001-151943 to practice as a professional nurse in the Commonwealth of Virginia. Said license expires on June 30, 2017.
2. By Order entered March 15, 2012 Mr. Matney was made subject to certain terms and conditions. One of the terms of this Order was Mr. Matney's compliance with all terms and conditions of his contract with the Health Practitioners' Monitoring Program ("HPMP"), pursuant to Chapter 25.1 of Title 54.1 of the Code of Virginia (1950), as amended, and 18 VAC 76-10-10, et seq., of the Regulations Governing the HPMP.
3. Mr. Matney has complied with all terms and conditions of the above Order; and has successfully completed his contract with the HPMP.

CONCLUSIONS OF LAW

The Board concludes that David Matney, R.N., has met the requirements of the Code of Virginia (1950), as amended, and the Regulations of the Board of Nursing, and the Order entered March 15, 2012, and this matter is properly before the Board.


ORDER

WHEREFORE, on the basis of the foregoing Findings of Fact and Conclusions of Law it is hereby ORDERED that the terms and conditions placed on the license of David Matney, R.N., to practice as a professional nurse in the Commonwealth of Virginia, be, and are hereby, TERMINATED.

Pursuant to § 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection or copying on request.


