CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Lauren A. Johnson, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Johnson's application for certification by examination to practice as a nurse aide in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Lauren Johnson submitted an application for certification by examination to practice as a nurse aide in the Commonwealth of Virginia on June 1, 2016.
- 2. Ms. Johnson violated Virginia Code § 54.1-3007(4) in that on February 11, 2010, she was convicted of felony larceny in the Greene County Juvenile and Domestic Relations Court. Ms. Johnson was sentenced to 12 months incarceration with 11 months suspended and ordered to pay restitution.
 - 3. Ms. Johnson provided evidence that she has made restitution to her victim.

- 1. I have been advised to seek advice of counsel prior to signing this document;

- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
 - 4. I waive all right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for certification by examination to practice as a nurse aide in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. Lauren A. Johnson is REPRIMANDED.
- 2. The application of Ms. Johnson for certification to practice as a nurse aide in the Commonwealth of Virginia is APPROVED. Upon successful completion of the NNAAP examination, Ms. Johnson shall be issued an unrestricted certification.
- 3. Ms. Johnson shall comply with all laws and regulations governing the practice of certified nurse aides in the Commonwealth of Virginia.

Pursuant to Virginia Code §§2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
