## NOTICE OF INFORMAL CONFERENCE AND STATEMENT OF ALLEGATIONS

You are hereby notified that an Informal Conference has been scheduled before the Board of Nursing ("Board") regarding your license to practice professional nursing in the Commonwealth of Virginia.

#### LEGAL AUTHORITY AND JURISDICTION:

- 1. This informal conference is being held pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10). This proceeding will be convened as a public meeting pursuant to Virginia Code § 2.2-3700.
- 2. At the conclusion of the proceeding, the Committee is authorized to take any of the following actions:
  - Exonerate you;
  - Reprimand you;
  - Require you to pay a monetary penalty;
  - Place you on probation and/or under terms and conditions;
  - Refer the matter to the Board of Nursing for a formal administrative hearing;
  - Offer you a consent order for suspension or revocation of your license in lieu of a formal hearing.

If you fail to appear at the informal conference, the Committee may proceed to hear this matter in your absence and may take any of the actions outlined above.

You have the right to the information on which the Committee will rely in making its decision, to be represented by counsel at this proceeding, to subpoena witnesses and/or documents, and to present relevant evidence on your behalf.

#### STATEMENT OF ALLEGATIONS

The Board of Nursing alleges that:

- 1. At all times relevant hereto, Carlton Nicholas Elam, III, R.N. was licensed to practice professional nursing in the Commonwealth of Virginia.
- 2. Carlton Nicholas Elam, III, R.N. violated Virginia Code § 54.1-3007(2), (5), and (8) and 18 VAC 90-20-300(A)(2)(f) of the Regulations Governing the Practice of Nursing ("Regulations") in that during the course of his employment with Amelia Nursing and Rehabilitation Center, Amelia, Virginia, on or about September 30, 2015, by his own admission, Mr. Elam used force to hold Resident A down in his wheelchair. Further, Mr. Elam spoke threateningly to and cursed at Resident A.
- 3. Mr. Elam violated Virginia Code § 54.1-3007(2) and 18 VAC 90-20-300(A)(2)(e) of the Regulations in that:
- a. On his application for employment with Amelia Nursing and Rehabilitation Center dated February 25, 2013, Mr. Elam wrote that his reason for leaving employment with HCA Chippenham Hospital, Richmond, Virginia, was "professional differences." In fact, Mr. Elam's employment HCA Chippenham Hospital was terminated in or about 2011.
- b. On his application for employment with Buckingham Correctional Center, Dillwyn, Virginia dated September 21, 2011, Mr. Elam wrote that his reason for leaving employment with HCA Chippenham Hospital was "lack of communications." In fact, Mr. Elam's employment HCA Chippenham Hospital was terminated in or about 2011.
- c. On his application for employment with ProNurses, Inc., Richmond, Virginia dated January 24, 2012, Mr. Elam wrote that his reason for leaving employment with HCA Chippenham

Hospital was "needed to change." In fact, Mr. Elam's employment HCA Chippenham Hospital was terminated in or about 2011.

d. On his application for employment with ManorCare, Richmond, Virginia dated September 26, 2012, Mr. Elam wrote that his reason for leaving employment with HCA Chippenham Hospital was "problems due to co-worker offense." In fact, Mr. Elam's employment HCA Chippenham Hospital was terminated in or about 2011.
