ORDER

JURISDICTION AND PROCEDURAL HISTORY

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), a Special Conference Committee of

the Virginia Board of Nursing ("Board") held an informal conference on June 2, 2016, in Henrico

County, Virginia, to inquire into evidence that Yvonne P. Sisk, R.N., may have violated certain laws

and regulations governing the practice of professional nursing in the Commonwealth of Virginia and

inquire into evidence that she may have violated an Order of the Board entered September 25, 2012.

Yvonnda Pendergrass Sisk, R.N. did not appear at this proceeding and was not represented by

legal counsel.

NOTICE

By letter dated May 4, 2016, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms. Sisk notifying her that an informal conference would be held on June 2, 2016. The

Notice was sent by certified and first class mail to the legal address of record on file with the Board of

Nursing. The receipt for the Notice sent via certified mail was signed by Ms. Sisk and returned to the

Board office on May 20, 2016. The Notice sent via first-class mail was not returned to the Board office

Accordingly, the Committee Chair concluded that adequate notice was provided to Ms. Sisk and the

informal conference proceeded in her absence.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and

Conclusions of Law and issues the Order contained herein.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Yvonnda Pendergrass Sisk, R.N. was issued License Number 0001-085825 to practice

professional nursing on September 15, 1982, which is scheduled to expire on May 31, 2018. At all

times relevant to the allegations contained herein, said license was in full force and effect. Her primary

state of residence is Virginia.

2. Ms. Sisk violated Term No. 1(b) of the Board's Order, which required her to notify the

Board of any changes in employment practice within ten days, in that she failed to notify the Board

that her employment with Virginia Center for Behavioral Rehabilitation was terminated in July 2015

within ten days of the termination.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of

Nursing hereby ORDERS as follows:

1. Yvonne P. Sisk, R.N., is hereby REPRIMANDED.

2. It is ORDERED that the terms and conditions placed on the license of Yvonnda

Pendergrass Sisk to practice professional nursing in the Commonwealth of Virginia are

TERMINATED and Yvonnda Pendergrass Sisk shall be issued an unrestricted license.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall

remain in the custody of the Department of Health Professions as a public record, and shall be made

available for public inspection and copying upon request.
