## FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Cynthia Elaine Bell-Clyde, L.P.N. was issued License Number 0002-044901 to practice practical nursing on September 27, 1991. Said license is scheduled to expire on April 30, 2017.
- 2. Ms. Bell-Clyde violated Virginia Code § 54.1-3007(2) and (5) and 18 VAC 90-20-300(A)(2)(e) of the Regulations Governing practical nursing in that on April 8, 2015, during her employment as a practical nurse with Maxim Healthcare Services, Virginia Beach, Virginia, she falsified a nursing flow sheet for Patient A, in that she submitted two different flow sheets for April 8, 2015 and documented substantially different patient care information and hours worked.

available for public inspection and copying upon request.
