Dear Ms. Wilson:

Pursuant to Virginia Code § 54.1-2409, you are hereby given notice that your certificate to practice as a nurse aide in the Commonwealth of Virginia has been mandatorily suspended by the enclosed Order entered June 27, 2016. You are hereby advised that, pursuant to Virginia Code § 54.1-2409.1, any person who practices a profession or occupation after having their license or certificate to do so suspended shall be guilty of a felony. Please return your certificate to Jay P. Douglas, Executive Director of the Virginia Board of Nursing ("Board"), at the above address, immediately upon receipt of this letter.

Virginia Code § 54.1-2409 further provides that you may apply to the Board for reinstatement of your certificate, and that you shall be entitled to a formal administrative hearing not later than the next regular meeting of the Board after the expiration of 60 days from the Board's receipt of your reinstatement application. You have the following rights, among others: to be represented by counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your certificate shall require the affirmative vote of three-fourths of the members of the Board present at the hearing.

ORDER OF MANDATORY SUSPENSION

In accordance with Virginia Code § 54.1-2409, I, David E. Brown, D.C., Director of the Virginia Department of Health Professions, received and acted upon evidence that Sandra Gail Wilson, C.N.A., was convicted of the following felony offenses in the Circuit Court of Tazewell County, Virginia: two counts of credit card fraud. A certified copy of the Dispositional Plea entered June 13, 2016, is attached to this Order and is marked as Commonwealth's Exhibit No. 1.

WHEREUPON, by the authority vested in the Director of the Department of Health Professions pursuant to Virginia Code § 54.1-2409, it is hereby ORDERED that the certificate of Ms. Wilson to practice as a certified nurse aide in the Commonwealth of Virginia is hereby SUSPENDED.

Upon entry of this Order, the certificate of Ms. Wilson will be recorded as suspended and no longer current and valid. Should Ms. Wilson seek reinstatement of her certificate pursuant to Virginia Code § 54.1-2409, she shall be responsible for any fees that may be required for the reinstatement of the certificate prior to issuance of the certificate to resume practice.

Pursuant to Virginia Code § 2.2-4023 and § 54.1-2400.2(G), the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection or copying on request.

Defendant represented that she was familiar with the details of each and every charge against her and waived formal arraignment on the charges.

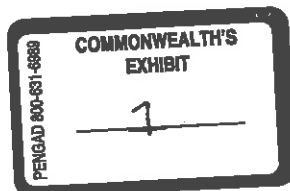

- UPON SENTENCING
- SHALL COMPLY WITH ALL RULES AND REQUIREMENTS SET BY PROBATION OFFICER.

PROBATION AND PAROLE LITTER PICK-UP PROGRAM: The Defendant shall be a participant in the Probation and Parole Litter Pick-Up Program, also known as the Assign-A-Highway Program. Defendant shall pick up litter along a section of public roadway or waterway, a local landfill, or participate in clean-up and litter removal activities in county locations as assigned by the director of the program, or his or her designee, pursuant to the rules of the program. Defendant may also be assigned to recycling duties at a locality designated by the Probation Office at public landfills, transfer sites, or other trash collection/processing systems. Participation in this program is a condition of the Defendant's probation.

COSTS: The Defendant shall pay the costs incurred by the Commonwealth, plus attorney fees in these cases.

ADDITIONAL REQUIREMENTS: Defendant is directed to submit to a sample for DNA analysis.

RESTITUTION: The Defendant shall make restitution and interest, when applicable, as follows to be monitored by Probation and Parole:

CREDIT FOR TIME SERVED: It is further ORDERED by the Court that the Defendant be given credit for time served pursuant to Code §53.1-187, which shall include credit for completed Detention Center, Diversion Center, as well as any other Department of Corrections treatment programs.
