ORDER

JURISDICTION AND PROCEDURAL HISTORY

Pursuant to Virginia Code §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11), a panel of the Virginia Board of Nursing ("Board") held a formal administrative hearing on May 19, 2016, in Henrico County, Virginia, to inquire into evidence that Tina Marie Clapp Alls, C.N.A. may have violated certain laws and regulations governing the practice of a certified nurse aide in the Commonwealth of Virginia.

Tina Marie Clapp Alls, C.N.A. appeared at this proceeding and was represented by Henry Woodward, Esquire.

NOTICE

By letter dated April 28, 2016, the Board of Nursing sent a Notice of Formal Hearing ("Notice") to Ms. Alls notifying her that a formal administrative hearing would be held on May 19, 2016. The Notice was sent by certified and first class mail to the legal address of record on file with the Board of Nursing.

Upon consideration of the evidence, the Board adopts the following Findings of Fact and Conclusions of Law and issues the Order contained herein.

FINDINGS OF FACT

1. Tina M. Alls, C.N.A. was issued Certificate No. 1401-168117 to practice nursing by the Virginia Board of Nursing on July 2, 2014. Said certificate is scheduled to expire on July 31, 2016.

- 2. On her application for employment with Nursefinders, Roanoke, Virginia, dated December 3, 2014:
- a. Ms. Alls failed to provide a "reason for leaving" her employment with South Roanoke Nursing Home, Roanoke, Virginia. In fact, Ms. Alls' employment with South Roanoke Nursing Home was terminated on October 26, 2014.
- b. Ms. Alls failed to list her previous employment with Berkshire Health and Rehabilitation Center, Vinton, Virginia and Team Nurse, South Boston, Virginia, both of which ended in termination.
- 3. Ms. Alls testified that she has learned that she needs to write all of her work history on future applications, because telling the truth is better than hiding anything.

CONCLUSION OF LAW

Findings of Fact Nos. 2(a) and 2(b) constitute a violation of Virginia Code § 54.1-3007(2) and 18 VAC 90-25-100(2)(d) of the Regulations Governing Certified Nurse Aides.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

Tina Marie Clapp Alls is REPRIMANDED.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
