CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Laura Jane Jennings Ramsey, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Ramsey's application for certification by endorsement to practice as a nurse aide in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Laura Jane Jennings Ramsey submitted an application for certification by endorsement to practice as a nurse aide in the Commonwealth of Virginia on February 23, 2016. Ms. Ramsey holds certification No. 174051 to practice as a nurse aide in the state of Tennessee. Said certification shall expire on December 10, 2017.
2. Ms. Ramsey violated Virginia Code § 54.1-3007(4) in that on April 2, 2015, she was convicted in the Circuit Court for Scott County, Virginia, of one count of welfare fraud, larceny under \$200.00, a misdemeanor involving moral turpitude. She was sentenced to 12 months incarceration with all 12 months suspended. She was placed on supervised probation for 12 months, and ordered to pay restitution and perform 250 hours of community service. The community service hours were later amended to a fine.
3. Ms. Ramsey was released from her supervised probation on March 21, 2016.
4. Ms. Ramsey otherwise meets the requirements of Virginia Code §54.1-3024.

CONSENT

Laura Jane Jennings Ramsey, by affixing her signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;

2. I am fully aware that without my consent, no legal action can be taken against me or my certificate except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 *et seq.*;

3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;

4. I waive all right to an informal conference;

5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;

6. I consent to the entry of the following Order affecting my application for certification to practice as a nurse aide in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

1. The application of Laura Jane Jennings Ramsey for certification to practice as a nurse aide in the Commonwealth of Virginia is APPROVED. Ms. Ramsey shall be issued an unrestricted certificate.

2. Ms. Ramsey is REPRIMANDED.

3. Ms. Ramsey shall comply with all laws and regulations governing the practice of nurse aides in the Commonwealth of Virginia.

Pursuant to Virginia Code §§2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.

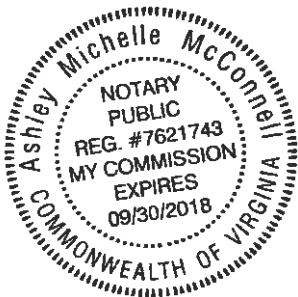
